



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 146 companies were dissolved in Solihull during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter


A total of 303 companies were added to the company register for Solihull in 2011. This number represents growth of 34.6% which compares equally to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)




Net company growth for Solihull during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 71 companies.



net growth by quarter






company share by year







director age by year




director age by half year


director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)
