

A total of 271 companies were formed in South Shields in 2011. This total is 29.7% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

Q4 2011 saw a new record in company registrations in South Shields when compared to any previous Q4.


Q4 2011 was a record quarter for company registrations in South Shields when compared to any quarter in history.



# Half Year Data (Jul-Dec 2011)


The second half of 2011 saw a new record in company closures in South Shields when compared to any previous second half year.

In the second half of 2011 a total of 83 companies were dissolved in South Shields. This figure is 20.3% higher than last year, which compares badly to the UK wide change of -7.5%.

#### dissolved companies by half year




Q4 2011 saw a new record in company closures in South Shields when compared to any previous Q4.




#### dissolved companies by quarter

2011 was a record year for net growth in South Shields when compared to any year in history.


A total of 121 companies were added to the company register for South Shields in 2011. This number represents growth of 57.9% which compares favourably to the UK figure of 34.6%.

#### net growth by year




## Half Year Data (Jul-Dec 2011)




Net company growth for South Shields during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 32 companies.

This represents an increase of 88.2% on the same period last year.






company share by year



company share by half year





The percentage of directors over the age of 65 was 4.3% compared to the UK figure of 4.1%.




#### director age by half year

#### director gender by year




# Half Year Data (Jul-Dec 2011)
