

A total of 674 companies were formed in Southall in 2011. This total is 0.0% the same as in 2010 and compares favourably to the UK figure of a 13.1% growth compared to 400,358 the previous year.


Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 355 companies were formed in Southall. This figure is 0.6% higher than last year, which compares badly to the UK wide figure of 14.0%.

new companies by half year




A total of 157 companies were registered in Southall during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


new companies by quarter



dissolved companies by year




Half Year Data (Jul-Dec 2011)




A total of 119 companies were dissolved in Southall during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter


A total of 220 companies were added to the company register for Southall in 2011. This number represents growth of 32.6% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Southall during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 38 companies.








company share by half year





director age by year





director age by half year



director gender by year




Half Year Data (Jul-Dec 2011)
