

A total of 108 companies were formed in Southam in 2011. This total is 22.7% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

The second half of 2011 saw a new record in company registrations in Southam when compared to any previous second half year.


The second half of 2011 was a record second half year for company registrations in Southam when compared to any half year in history.

new companies by half year




Quarterly Data (Q4 Oct-Dec 2011)



dissolved companies by year




Half Year Data (Jul-Dec 2011)




A total of 12 companies were dissolved in Southam during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 51 companies were added to the company register for Southam in 2011. This number represents growth of 58.0% which compares favourably to the UK figure of 34.6%.




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Southam during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 18 companies.

net growth by quarter






company share by year







director age by year




director age by half year


director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)
