


Half Year Data (Jul-Dec 2011)




A total of 166 companies were registered in Southend-On-Sea during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)




A total of 200 companies were dissolved in Southend-On-Sea during the fourth quarter of 2011 (Oct 2011 - Dec 2011).








Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Southend-On-Sea during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was -34 companies.





company share by year




company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)

director gender by half year


