

#### new companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 276 companies were formed in Southport. This figure is 4.2% lower than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Southport occurred in 2003 when a total of 322 were formed.

#### new companies by half year




A total of 122 companies were registered in Southport during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### new companies by quarter



#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

#### dissolved companies by half year




Q4 2011 saw a new record in company closures in Southport when compared to any previous Q4.


#### dissolved companies by quarter


A total of 191 companies were added to the company register for Southport in 2011. This number represents growth of 33.3% which compares unfavourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Southport during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 21 companies.

This represents a decrease of 27.6% on the same period last year.





#### company share by year




#### company share by half year





#### director age by year





#### director age by half year



The percentage of directors over the age of 65 was 9.9% compared to the UK figure of 4.1%.


#### director age by quarter

#### director gender by year




## Half Year Data (Jul-Dec 2011)
