

A total of 393 companies were formed in Spalding in 2011. This total is 35.5% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

The second half of 2011 saw a new record in company registrations in Spalding when compared to any previous second half year.


The second half of 2011 was a record second half year for company registrations in Spalding when compared to any half year in history.







#### dissolved companies by year




## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 118 companies were dissolved in Spalding. This figure is 1.7% higher than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Spalding occurred in 2009 when a total of 154 were closed.

#### dissolved companies by half year




A total of 64 companies were dissolved in Spalding during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### dissolved companies by quarter


A total of 181 companies were added to the company register for Spalding in 2011. This number represents growth of 62.4% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Spalding during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 39 companies.

This represents an increase of 254.5% on the same period last year.



#### net growth by month





#### company share by year




### company share by half year





#### director age by year





#### director age by half year




## director age by quarter

#### director gender by year




# Half Year Data (Jul-Dec 2011)
