
The first half of 2012 saw a new record in company registrations in Spalding when compared to any previous first half year.


# Quarterly Data (Q2 Apr-Jun 2012)





#### dissolved companies by half year




# Quarterly Data (Q2 Apr-Jun 2012)

A total of 41 companies were dissolved in Spalding during the second quarter of 2012 (Apr 2012 - Jun 2012).






Q2 2012 saw a new record in net growth in Spalding when compared to any previous Q2.

#### net growth by quarter






company share by half year





#### director age by half year




## Quarterly Data (Q2 Apr-Jun 2012)

#### director gender by half year




# Quarterly Data (Q2 Apr-Jun 2012)
