


The second half of 2011 saw a new record in company registrations in St Albans when compared to any previous second half year.

#### new companies by half year




A total of 264 companies were registered in St Albans during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 440 companies were dissolved in St Albans. This figure is 1.8% lower than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in St Albans occurred in 2009 when a total of 722 were closed.

## dissolved companies by half year




A total of 244 companies were dissolved in St Albans during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### dissolved companies by quarter


A total of 351 companies were added to the company register for St Albans in 2011. This number represents growth of 31.3% which compares unfavourably to the UK figure of 34.6%.

This number is 146 companies higher than the previous year.

The highest net company growth figure ever seen in one year came in 2007 when the St Albans company register grew by 1,051 companies.




#### Half Year Data (Jul-Dec 2011)




Net company growth for St Albans during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 20 companies.

This represents a decrease of 72.2% on the same period last year.








#### company share by half year





#### director age by year





#### director age by half year



#### director gender by year




## Half Year Data (Jul-Dec 2011)
