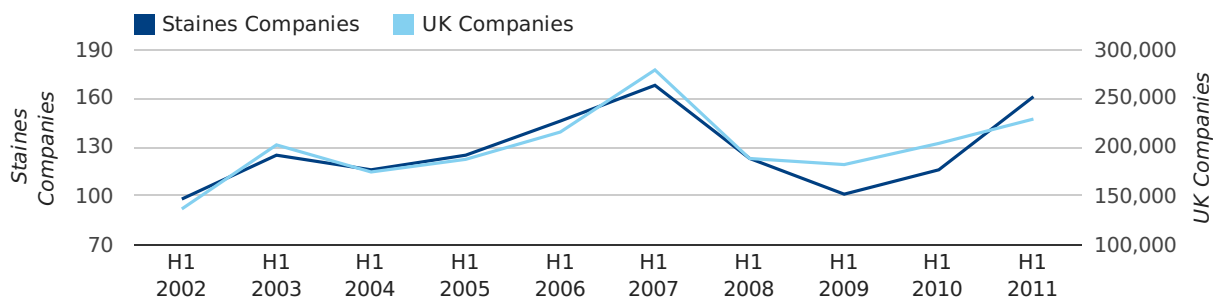
Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 161 companies were formed in Staines. This figure is 38.8% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Staines occurred in 2007 when a total of 168 were formed.

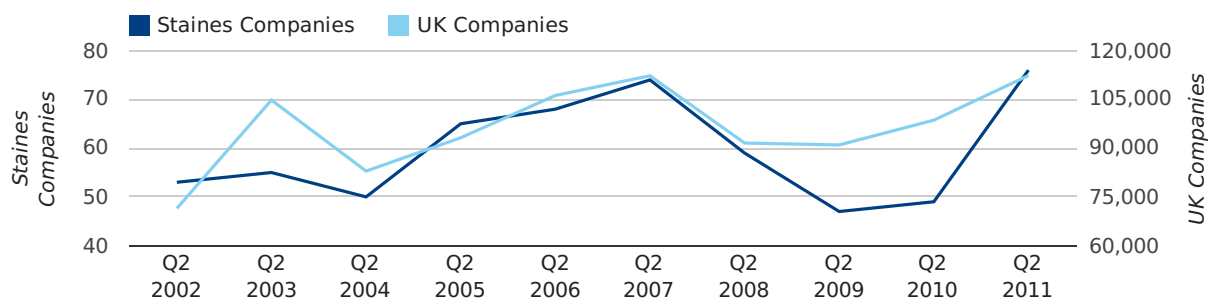
Q2 2011 saw a new record in company registrations in Staines when compared to any previous Q2.

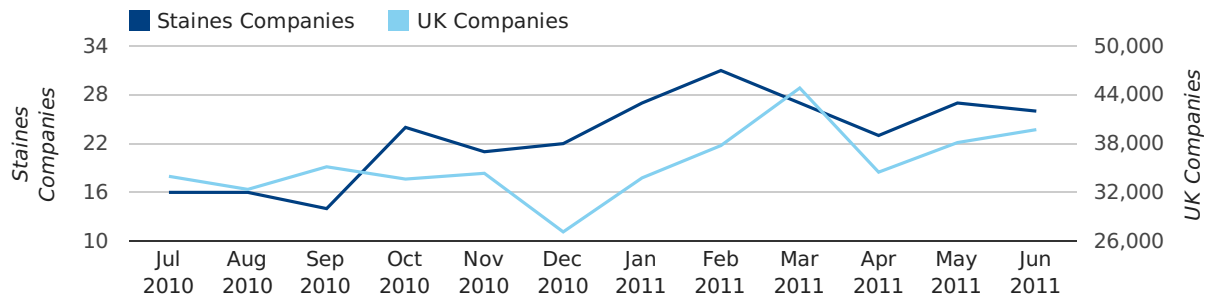

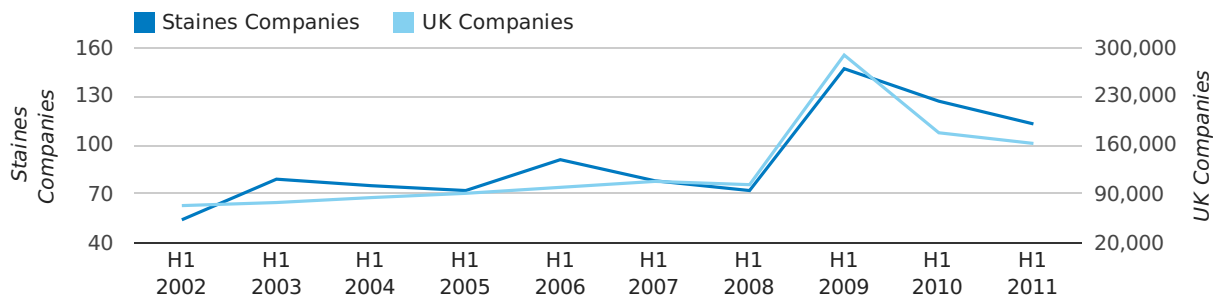
Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 113 companies were dissolved in Staines. This figure is 11.0% lower than last year, which compares well to the UK wide change of -8.6%.

The highest total for a first half year in Staines occurred in 2009 when a total of 147 were closed.

dissolved companies by half year



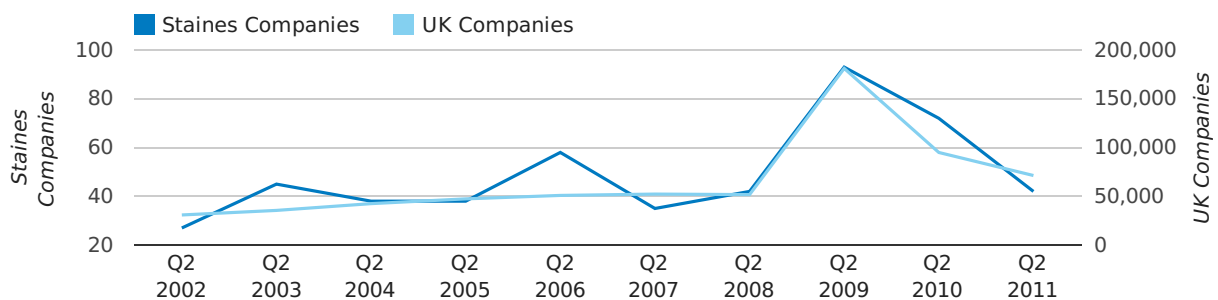
Quarterly Data (Q2 Apr-Jun 2011)

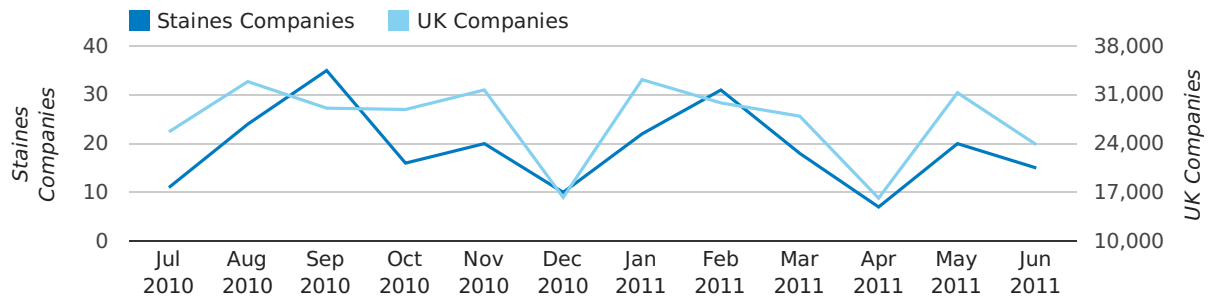

dissolved companies by month



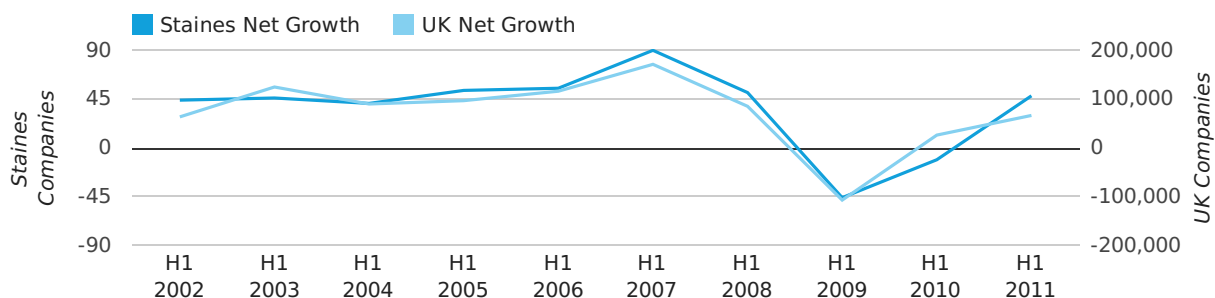

net growth by half year



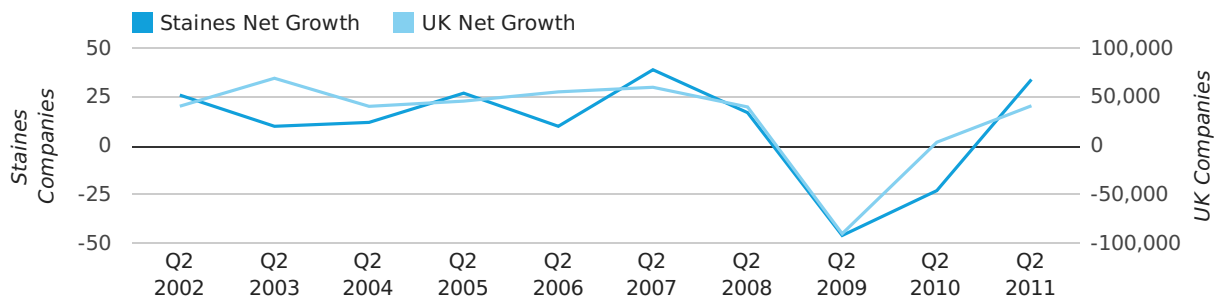

This represents an increase of 247.8% on the same period last year.

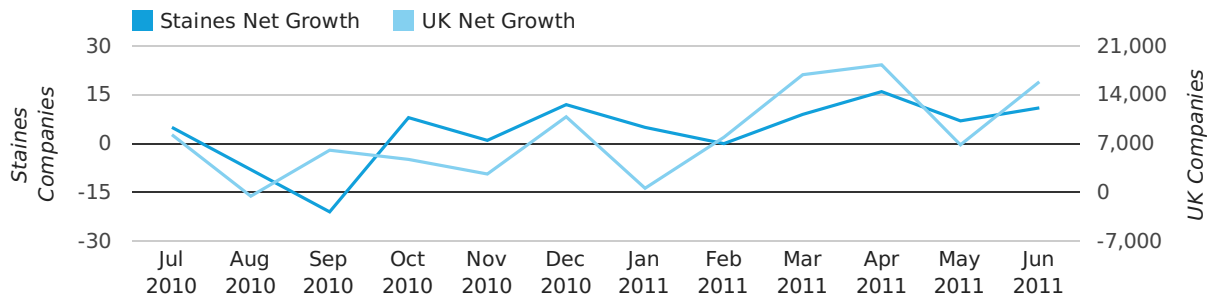

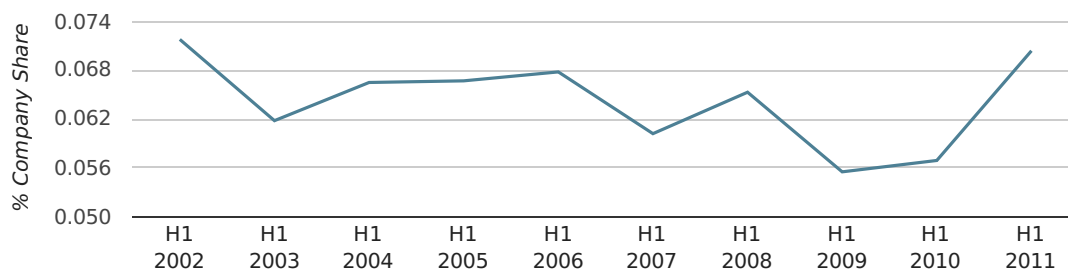

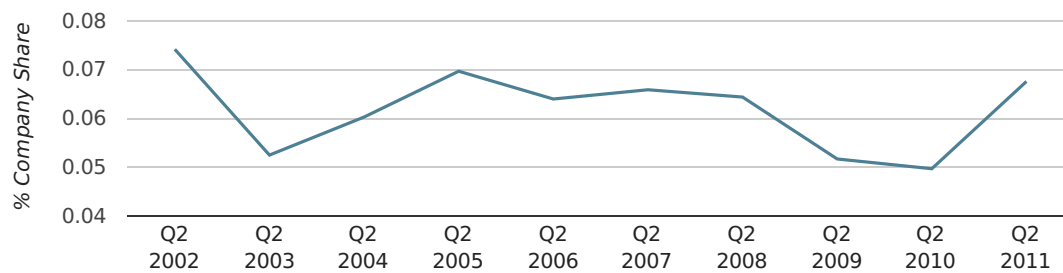

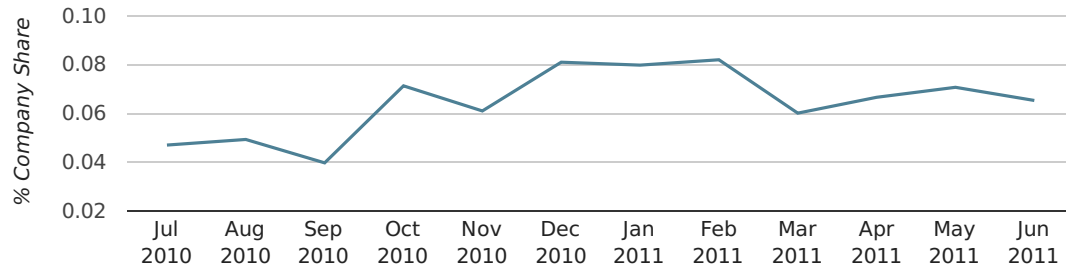

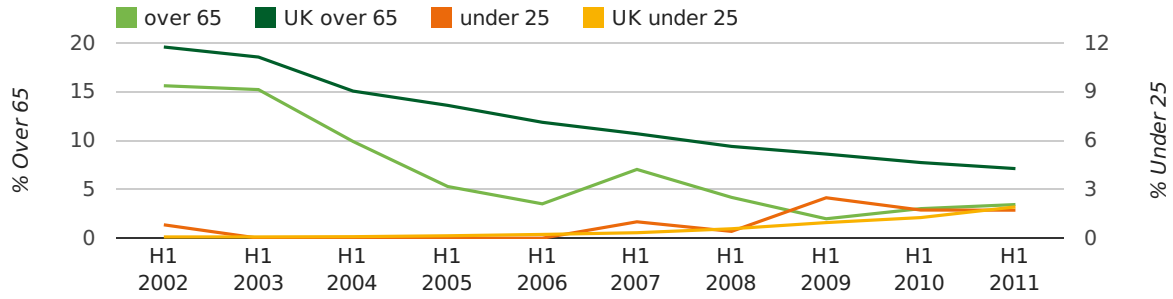

director age by half year



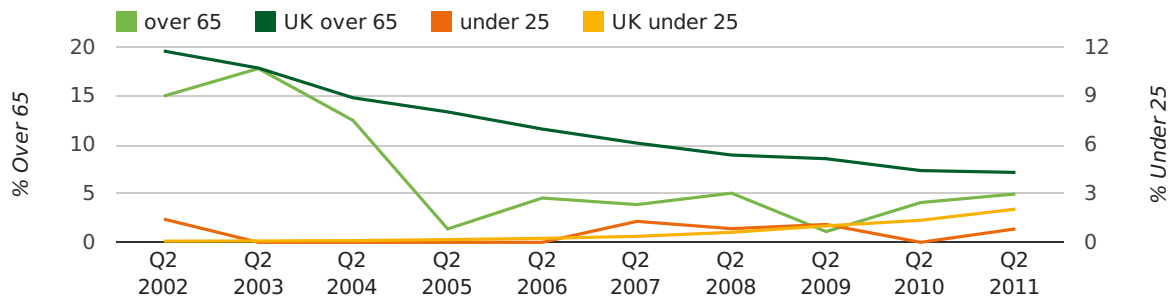

director age by quarter

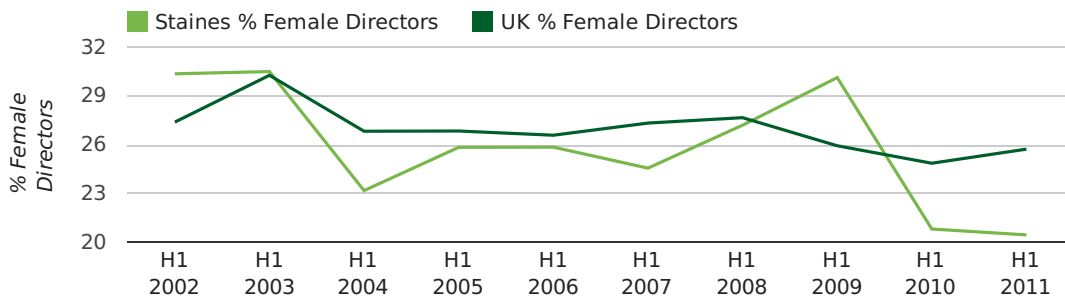


Half Year Data (Jan-Jun 2011)

director gender by half year

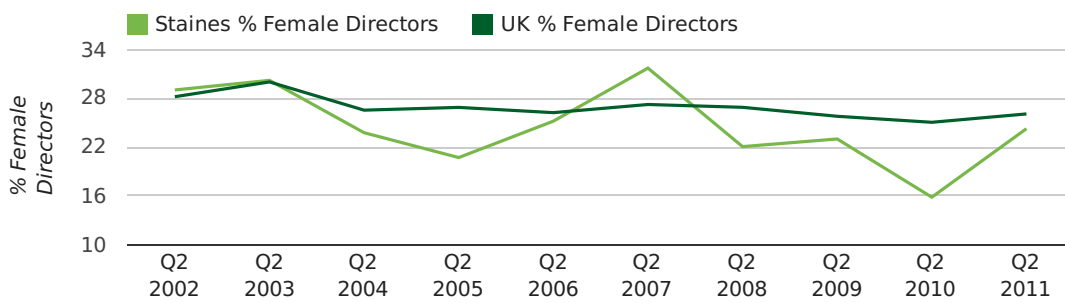


Quarterly Data (Q2 Apr-Jun 2011)
