

A total of 183 companies were formed in Stamford in 2011. This total is 9.6% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Stamford when compared to any previous second half year.

new companies by half year




Q4 2011 saw a new record in company registrations in Stamford when compared to any previous Q4.


new companies by quarter



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




Q4 2011 saw a new record in company closures in Stamford when compared to any previous Q4.


dissolved companies by quarter


A total of 79 companies were added to the company register for Stamford in 2011. This number represents growth of 47.3% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Stamford during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 21 companies.



net growth by month






company share by half year





director age by year





director age by half year



director gender by year


