

A total of 757 companies were formed in Stanmore in 2011. This total is 17.4% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

#### new companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 362 companies were formed in Stanmore. This figure is 18.7% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Stanmore occurred in 2004 when a total of 386 were formed.

#### new companies by half year




Q4 2011 saw a new record in company registrations in Stanmore when compared to any previous Q4.


#### new companies by quarter



#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 196 companies were dissolved in Stanmore. This figure is 15.9% lower than last year, which compares well to the UK wide change of -7.5%.

The highest total for a second half year in Stanmore occurred in 2007 when a total of 608 were closed.

## dissolved companies by half year




A total of 98 companies were dissolved in Stanmore during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 324 companies were added to the company register for Stanmore in 2011. This number represents growth of 50.2% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)




Net company growth for Stanmore during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 79 companies.

This represents an increase of 25.4% on the same period last year.





#### company share by year




#### company share by half year





#### director age by year




## Half Year Data (Jul-Dec 2011)

#### director age by half year




The average age of a director in the fourth quarter of 2011 was 42.2.

#### director gender by year




## Half Year Data (Jul-Dec 2011)
