




In the first half of 2012 a total of 326 companies were formed in Stevenage. This figure is 7.9% higher than last year, which compares badly to the UK wide figure of 10.7%.

The highest total for a first half year in Stevenage occurred in 2007 when a total of 349 were formed.


Q2 2012 saw a new record in company registrations in Stevenage when compared to any previous Q2.





#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)

A total of 109 companies were dissolved in Stevenage during the second quarter of 2012 (Apr 2012 - Jun 2012).





#### net growth by half year













#### director age by half year





The percentage of directors over the age of 65 was 2.5% compared to the UK figure of 3.3%.


#### director age by quarter

#### director gender by half year




# Quarterly Data (Q2 Apr-Jun 2012)
