

In the first half of 2011 a total of 334 companies were formed in Stockton-On-Tees. This figure is 23.7% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Stockton-On-Tees occurred in 2007 when a total of 369 were formed.


# Quarterly Data (Q2 Apr-Jun 2011)

Q2 2011 saw a new record in company registrations in Stockton-On-Tees when compared to any previous Q2.

A total of 182 companies were registered in Stockton-On-Tees during the second quarter of 2011 (Apr 2011 - Jun 2011).

This figure is an increase of 42.2% versus the same period last year (Q2 2010). This figure compares well to the UK as a whole, which saw an increase of 13.9% against the same period last year.




#### new companies by quarter



#### dissolved companies by half year




# Quarterly Data (Q2 Apr-Jun 2011)

A total of 90 companies were dissolved in Stockton-On-Tees during the second quarter of 2011 (Apr 2011 - Jun 2011).










company share by half year





#### director age by half year



The percentage of directors over the age of 65 was 1.9% compared to the UK figure of 4.3%.




### director age by quarter

#### director gender by half year




## Quarterly Data (Q2 Apr-Jun 2011)

The record second quarter for female directors in Stockton-On-Tees was in 1866 when 66.7% of all directors were female.
