

A total of 164 companies were registered in Stockton-On-Tees during the second quarter of 2012 (Apr 2012 - Jun 2012).








Quarterly Data (Q2 Apr-Jun 2012)












company share by half year





director age by half year



The percentage of directors under the age of 25 was 4.4% compared to the UK figure of 5.2%.


The percentage of directors over the age of 65 was 1.7% compared to the UK figure of 3.3%.

director gender by half year


