

2011 was a record year for company registrations in Stowmarket when compared to any year in history.

A total of 175 companies were formed in Stowmarket in 2011. This total is 22.4% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

### Half Year Data (Jul-Dec 2011)

The second half of 2011 saw a new record in company registrations in Stowmarket when compared to any previous second half year.

In the second half of 2011 a total of 93 companies were formed in Stowmarket. This figure is 43.1% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Stowmarket occurred in 2011 when a total of 93 were formed.

#### new companies by half year




Q4 2011 saw a new record in company registrations in Stowmarket when compared to any previous Q4.





# Half Year Data (Jul-Dec 2011)

The second half of 2011 saw a new record in company closures in Stowmarket when compared to any previous second half year.

In the second half of 2011 a total of 56 companies were dissolved in Stowmarket. This figure is 5.7% higher than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Stowmarket occurred in 2011 when a total of 56 were closed.

Q4 2011 saw a new record in company closures in Stowmarket when compared to any previous Q4.


A total of 29 companies were dissolved in Stowmarket during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 65 companies were added to the company register for Stowmarket in 2011. This number represents growth of 45.5% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Stowmarket during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 19 companies.




company share by year







#### director age by year



The percentage of directors over the age of 65 was 5.8% compared to the UK figure of 4.1%.




The average age of a director in the fourth quarter of 2011 was 46.7.

The record second half year for female directors in Stowmarket was 1860 when 42.9% of all directors were female.
