

new companies by year




Half Year Data (Jul-Dec 2011)


new companies by half year





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




Q4 2011 saw a new record in company closures in Sunderland when compared to any previous Q4.


dissolved companies by quarter


A total of 127 companies were added to the company register for Sunderland in 2011. This number represents growth of 23.6% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)




Net company growth for Sunderland during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 8 companies.

net growth by quarter






company share by year







director age by year




director age by half year

director gender by year




Half Year Data (Jul-Dec 2011)

26.1% of all director appointments in Sunderland in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


director gender by half year
