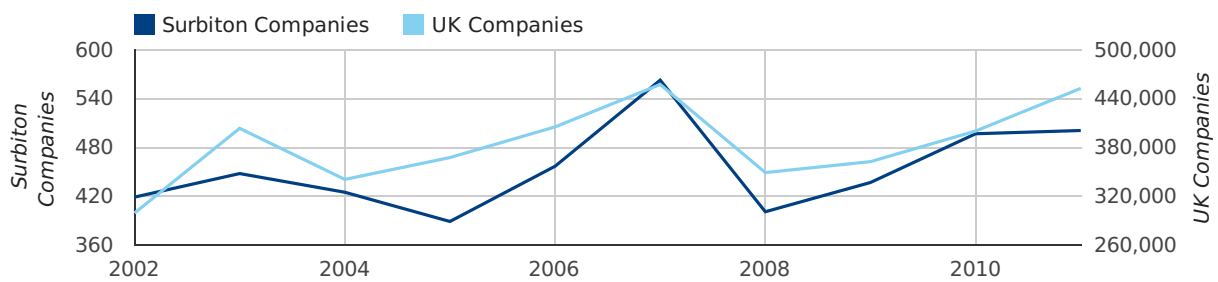

A total of 501 companies were formed in Surbiton in 2011. This total is 0.8% higher than in 2010 and compares favourably to the UK figure of a 13.1% growth compared to 400,358 the previous year.

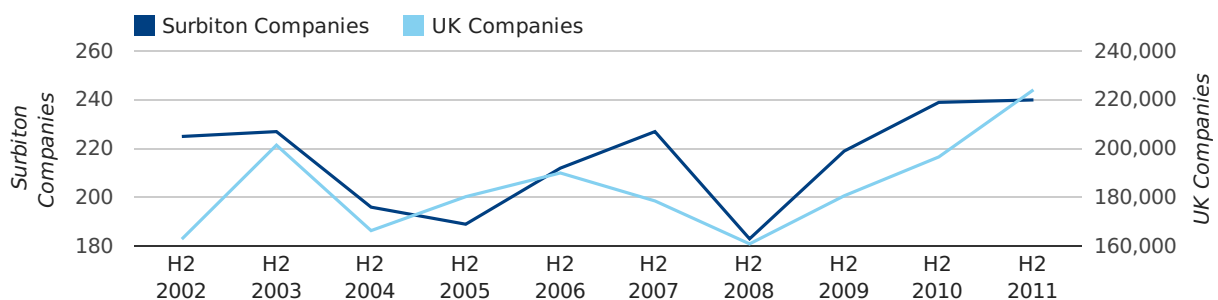
The second half of 2011 saw a new record in company registrations in Surbiton when compared to any previous second half year.

new companies by half year



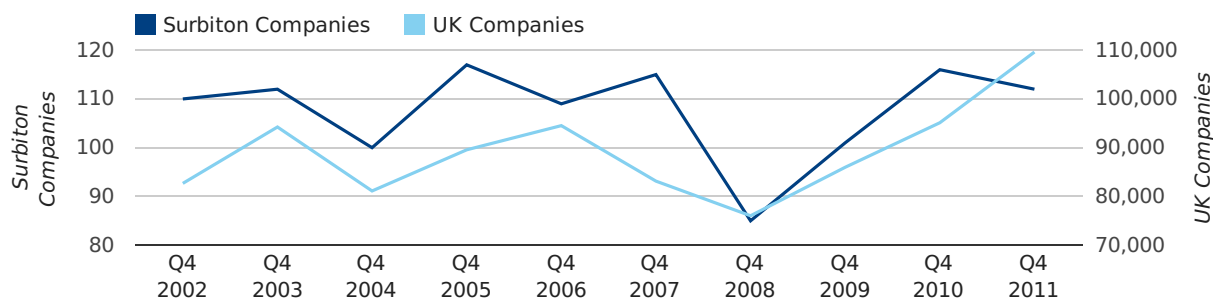
Quarterly Data (Q4 Oct-Dec 2011)

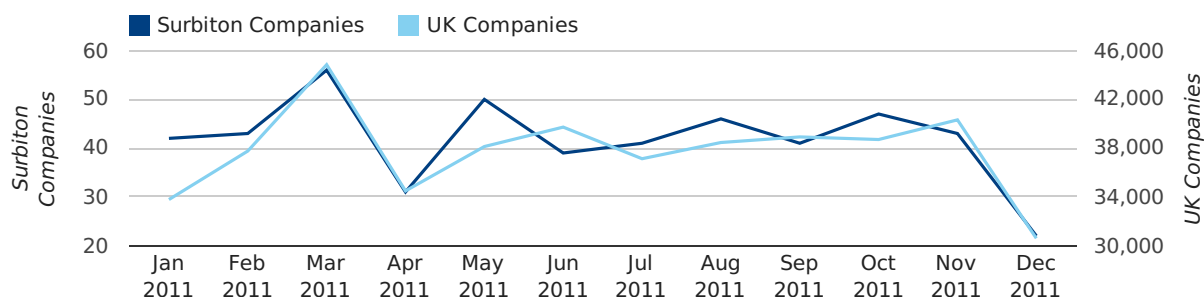

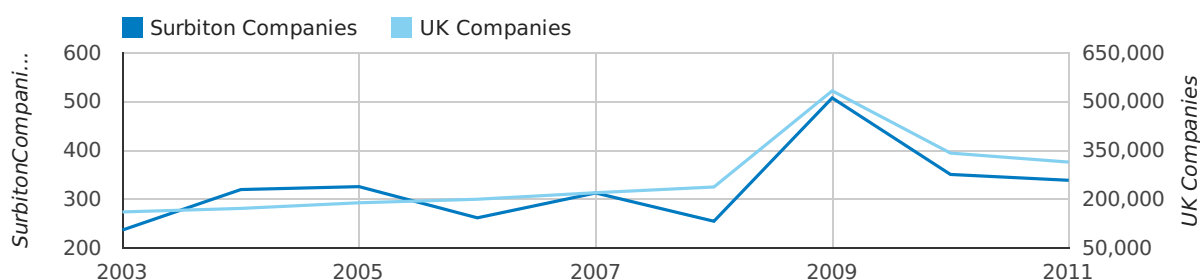

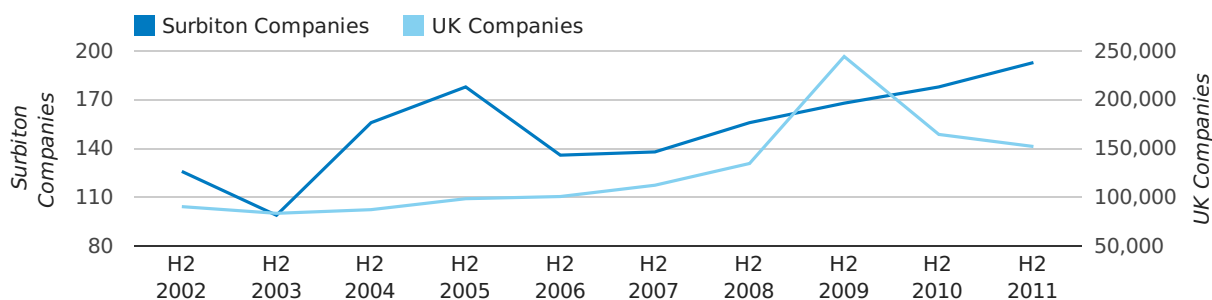
The second half of 2011 saw a new record in company closures in Surbiton when compared to any previous second half year.

In the second half of 2011 a total of 193 companies were dissolved in Surbiton. This figure is 8.4% higher than last year, which compares badly to the UK wide change of -7.5%.

dissolved companies by half year



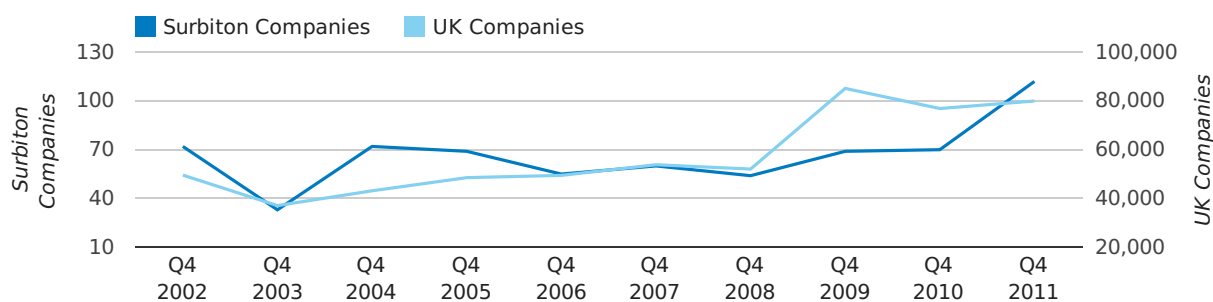
Quarterly Data (Q4 Oct-Dec 2011)

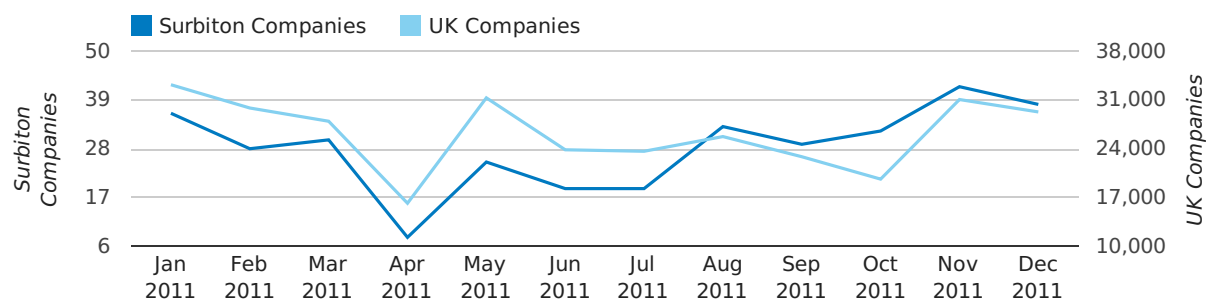
dissolved companies by quarter

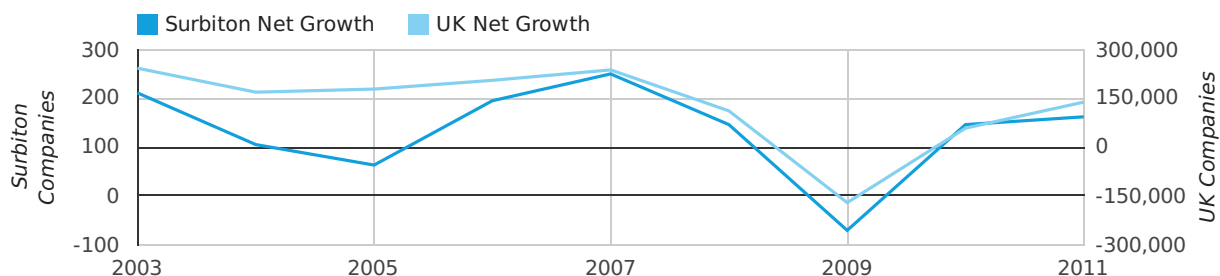
A total of 162 companies were added to the company register for Surbiton in 2011. This number represents growth of 32.6% which compares unfavourably to the UK figure of 34.6%.

net growth by year

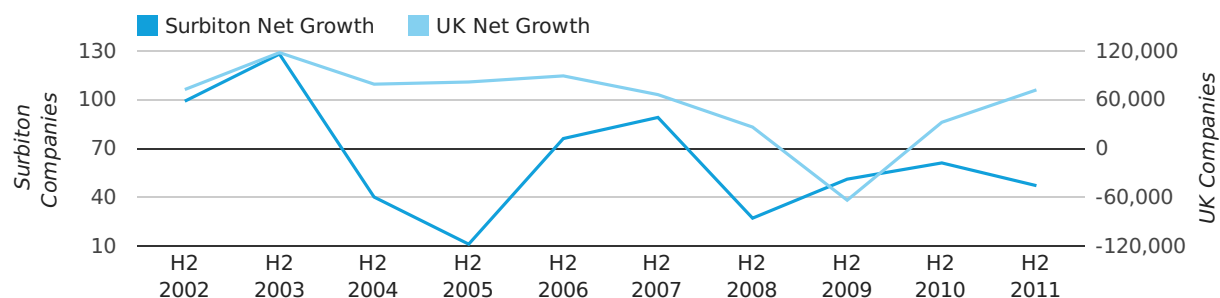


Half Year Data (Jul-Dec 2011)

net growth by half year



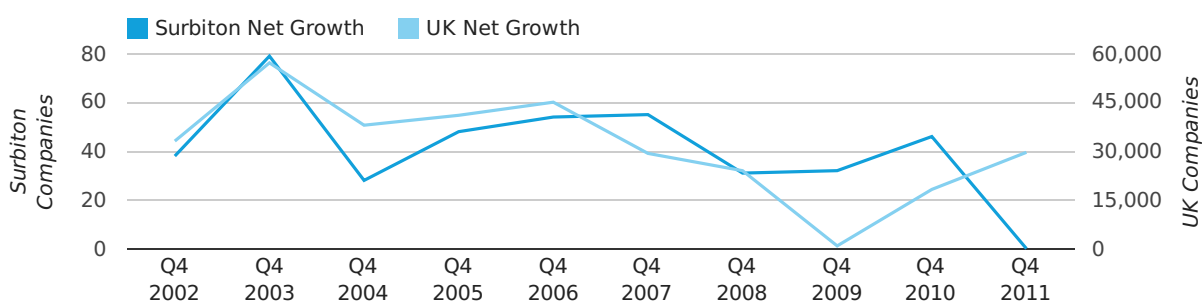

This represents a decrease of 100.0% on the same period last year.

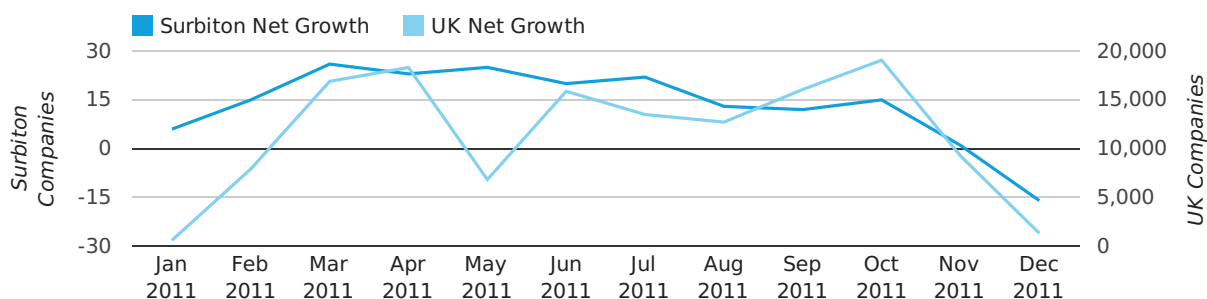

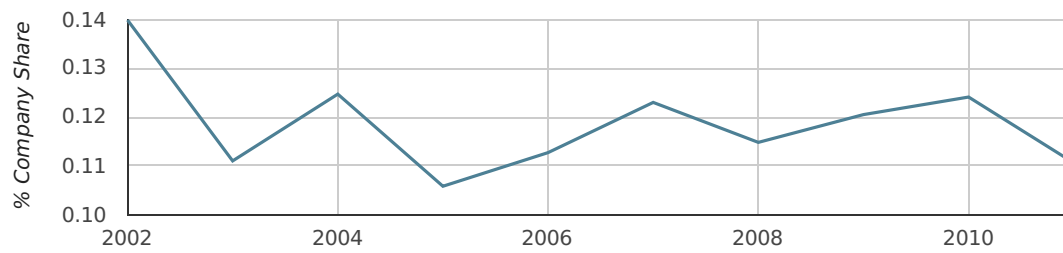

company share by year

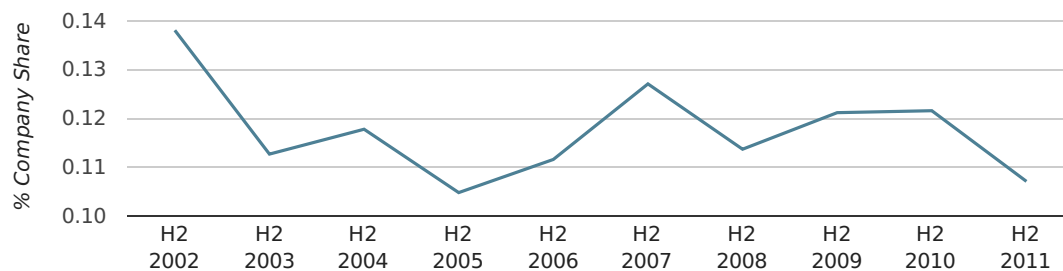

company share by half year

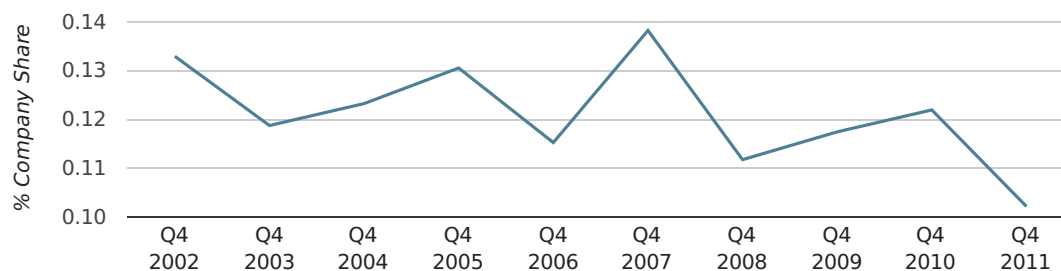

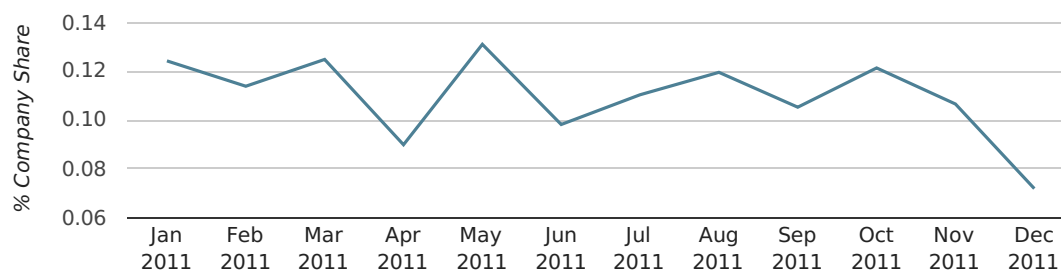

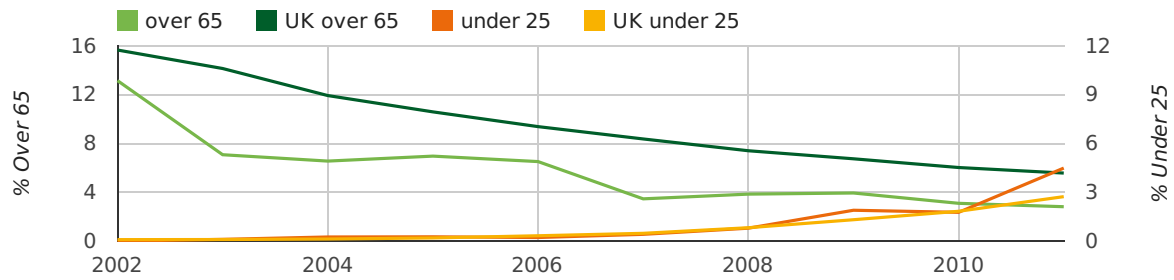

director age by year



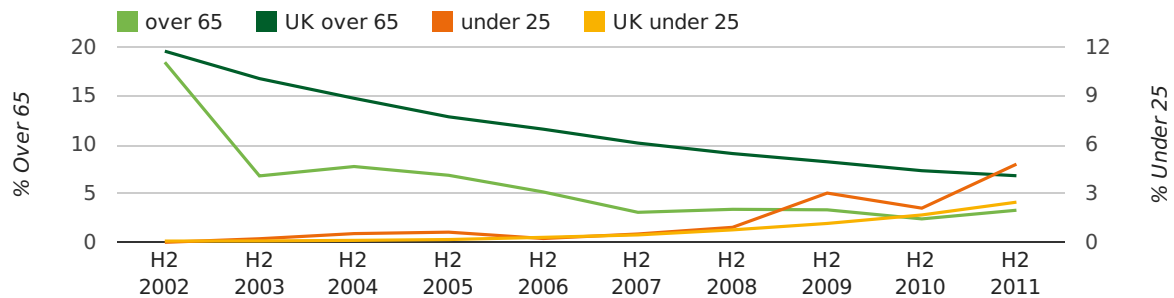

director age by half year



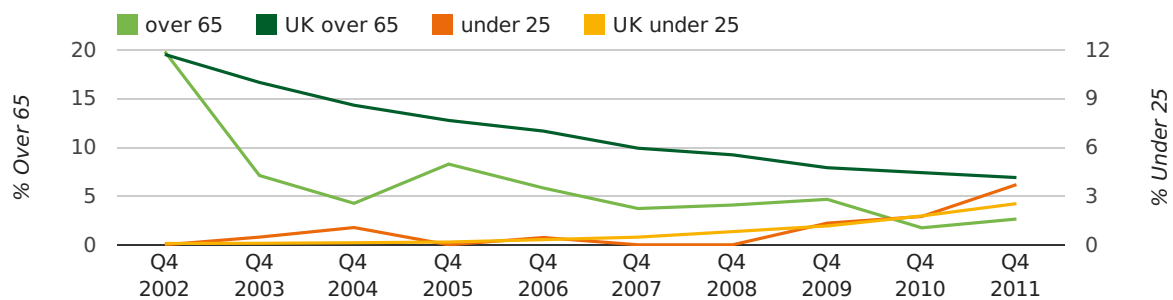

director age by quarter

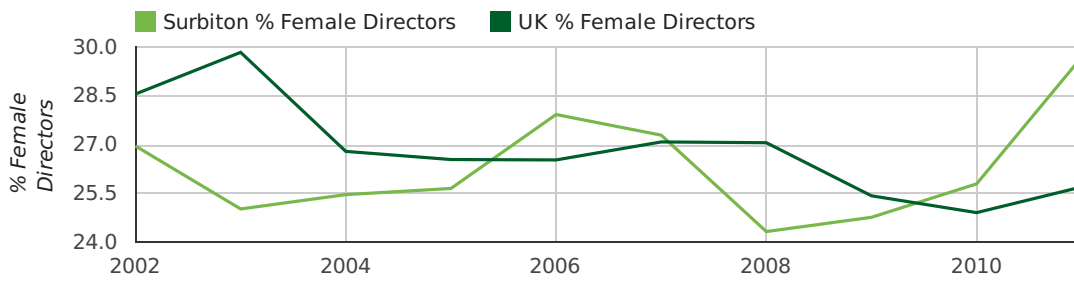


Annual Data (2011)

director gender by year

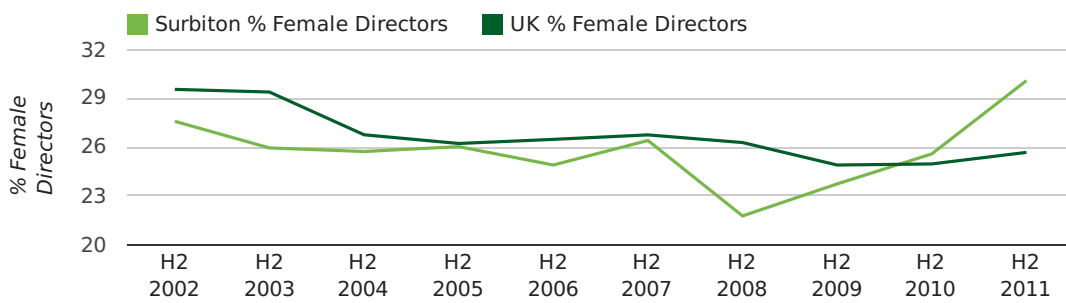


Half Year Data (Jul-Dec 2011)

director gender by half year

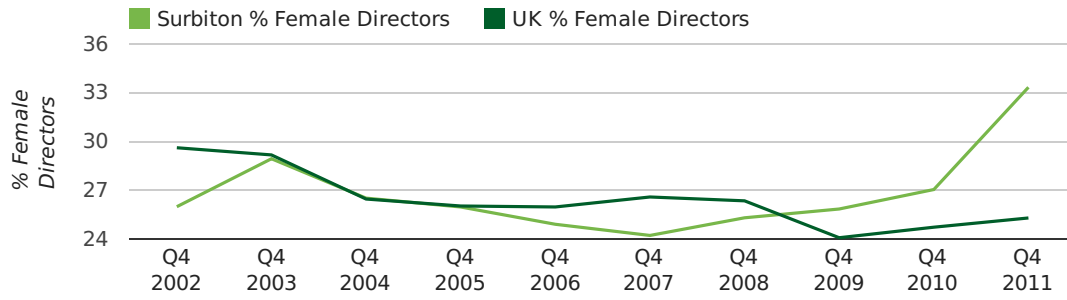


Quarterly Data (Q4 Oct-Dec 2011)
