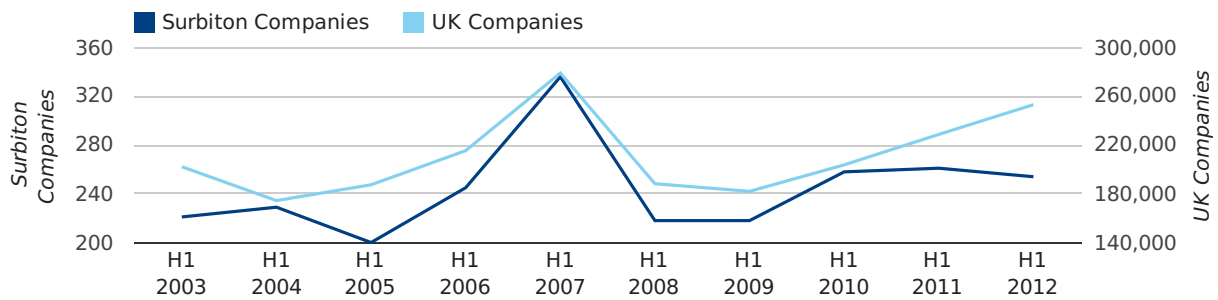
Half Year Data (Jan-Jun 2012)

In the first half of 2012 a total of 254 companies were formed in Surbiton. This figure is 2.7% lower than last year, which compares badly to the UK wide figure of 10.7%.

The highest total for a first half year in Surbiton occurred in 2007 when a total of 336 were formed.

new companies by half year



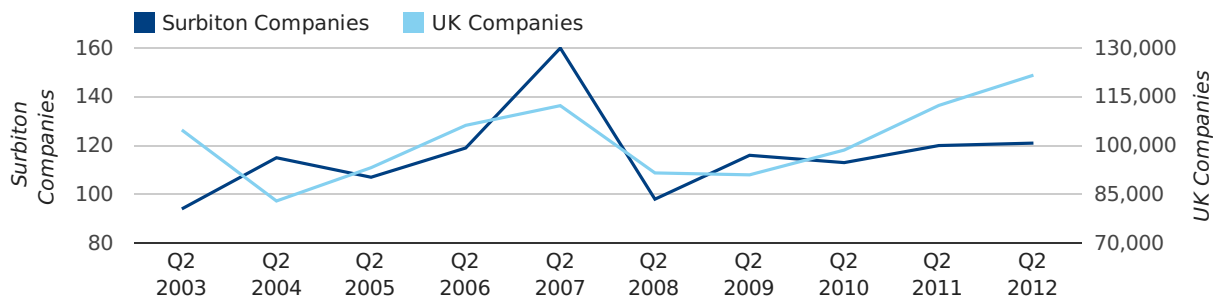
Quarterly Data (Q2 Apr-Jun 2012)

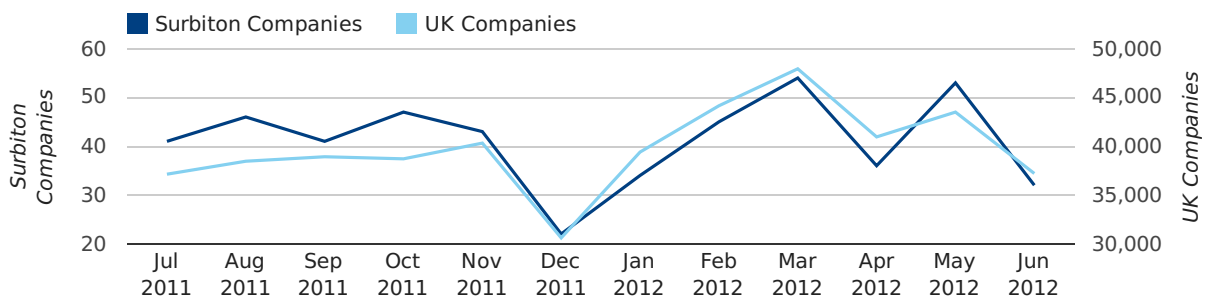
new companies by quarter

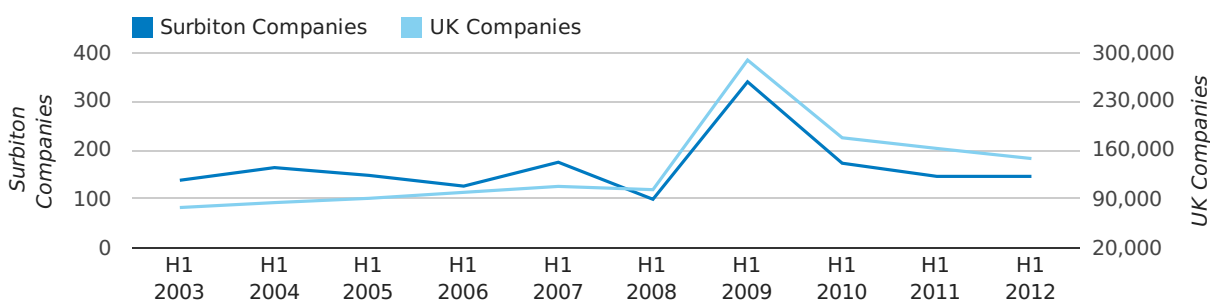
Half Year Data (Jan-Jun 2012)

dissolved companies by half year



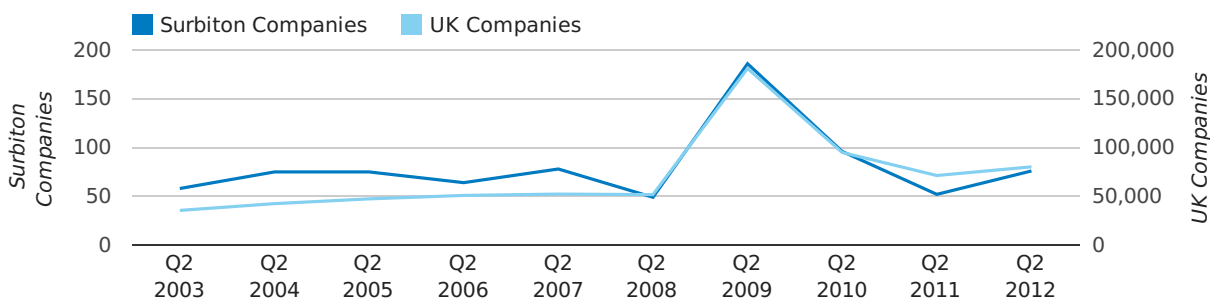
Quarterly Data (Q2 Apr-Jun 2012)

This figure is an increase of 46.2% versus the same period last year (Q2 2011). This figure compares poorly to the UK as a whole, which saw an increase of 12.5% against the same period last year.

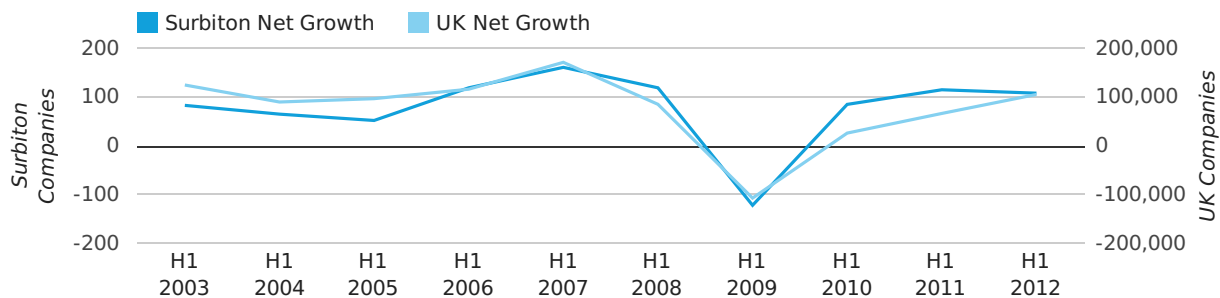

net growth by half year



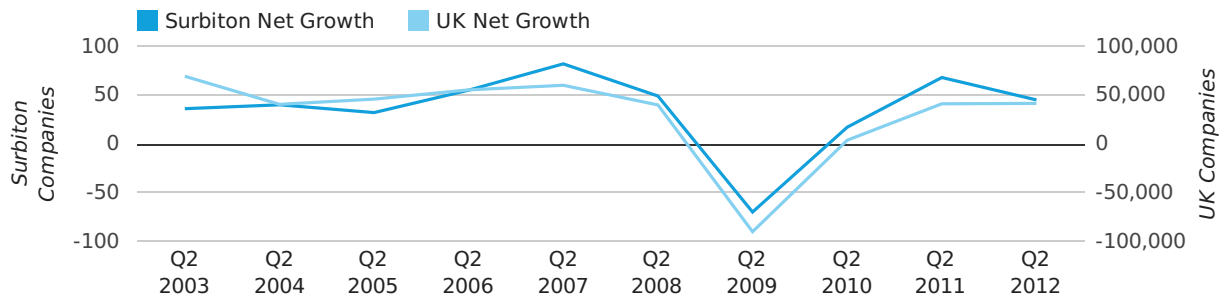
Quarterly Data (Q2 Apr-Jun 2012)

This represents a decrease of 33.8% on the same period last year.

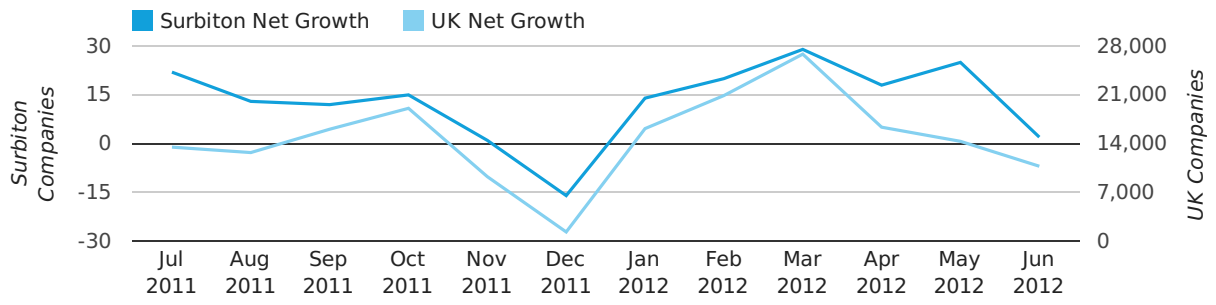

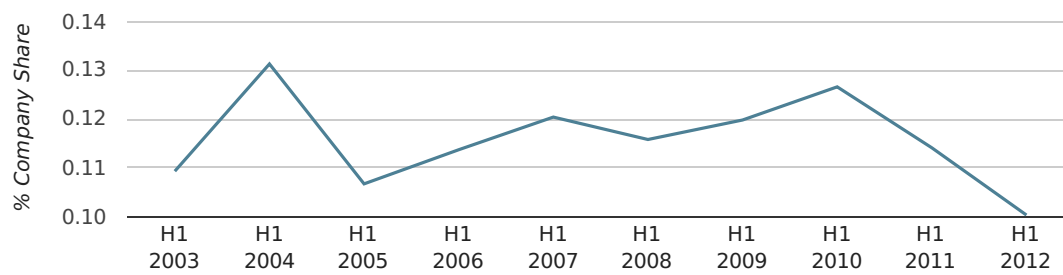

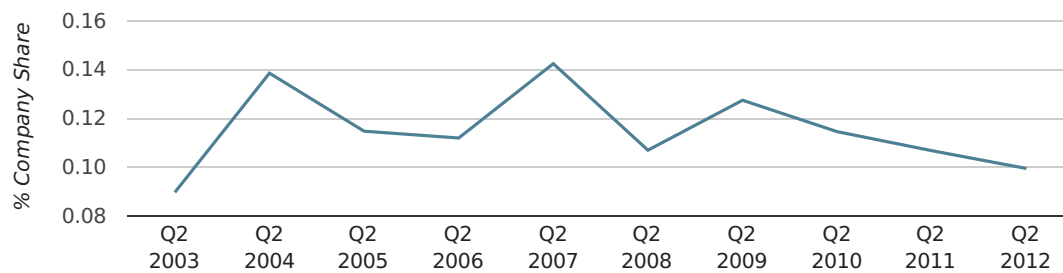

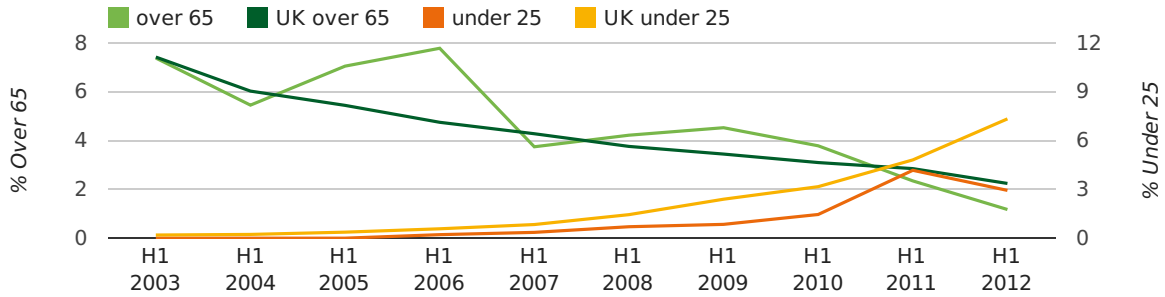
Half Year Data (Jan-Jun 2012)

director age by half year



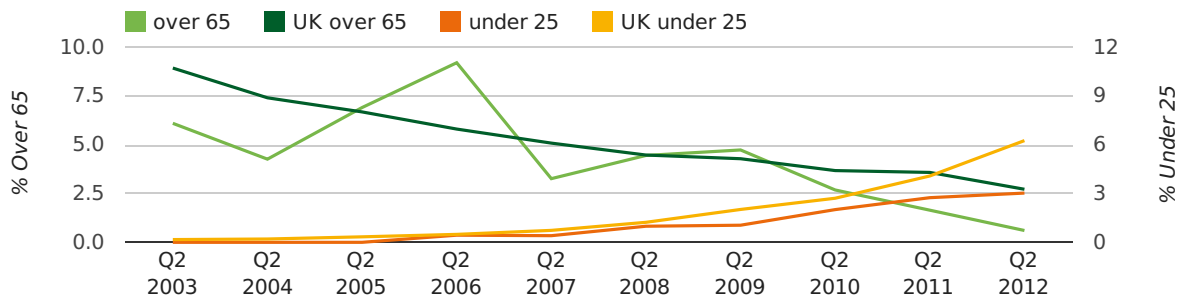
Quarterly Data (Q2 Apr-Jun 2012)

director age by quarter

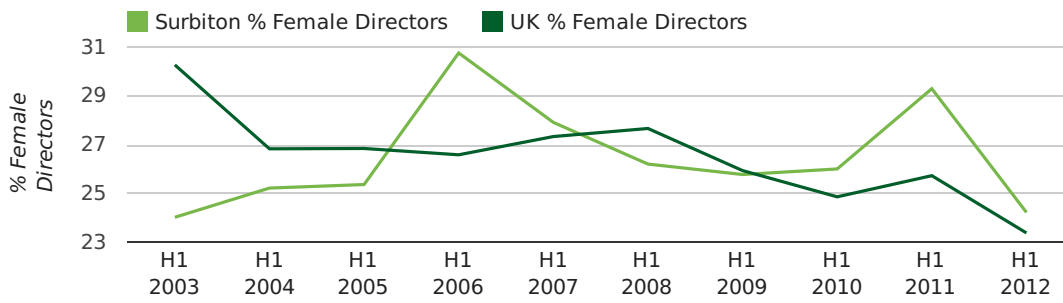


Half Year Data (Jan-Jun 2012)

The record first half year for female directors in Surbiton was 1861 when 40.0% of all directors were female.

24.2% of all director appointments in Surbiton in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.

director gender by half year

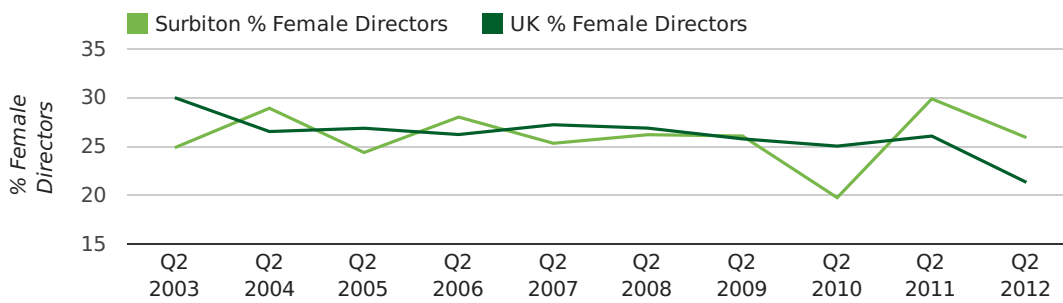


Quarterly Data (Q2 Apr-Jun 2012)

The record second quarter for female directors in Surbiton was in 1866 when 66.7% of all directors were female.

25.9% of all director appointments in Surbiton in the second quarter of 2012 were female. This compares to a UK average of 21.3% for the same period.
