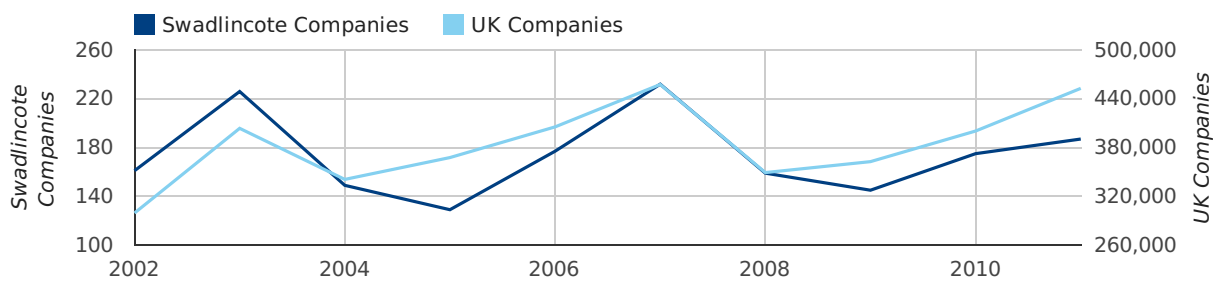

### Annual Data (2011)

A total of 187 companies were formed in Swadlincote in 2011. This total is 6.9% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

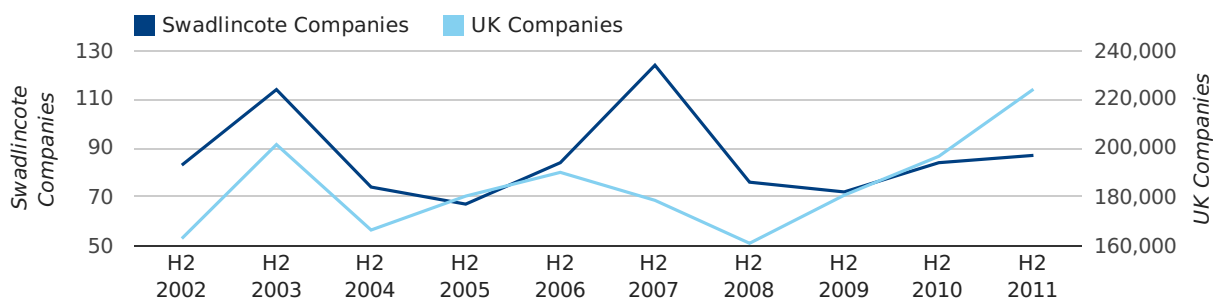
### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 87 companies were formed in Swadlincote. This figure is 3.6% higher than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Swadlincote occurred in 2007 when a total of 124 were formed.

### new companies by half year



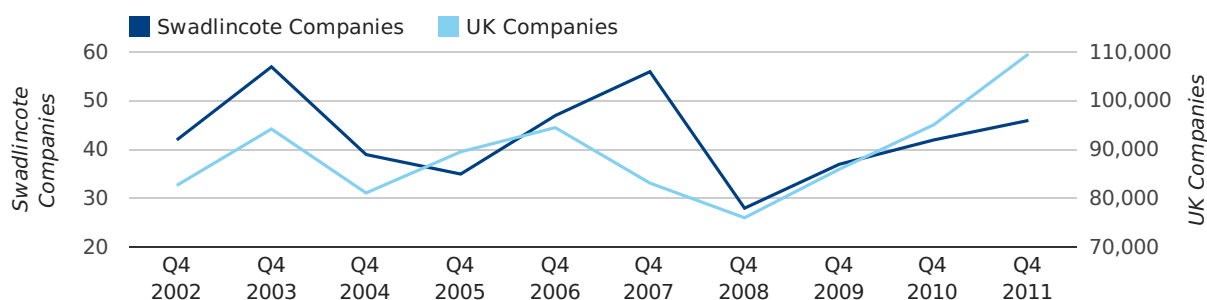
## Quarterly Data (Q4 Oct-Dec 2011)

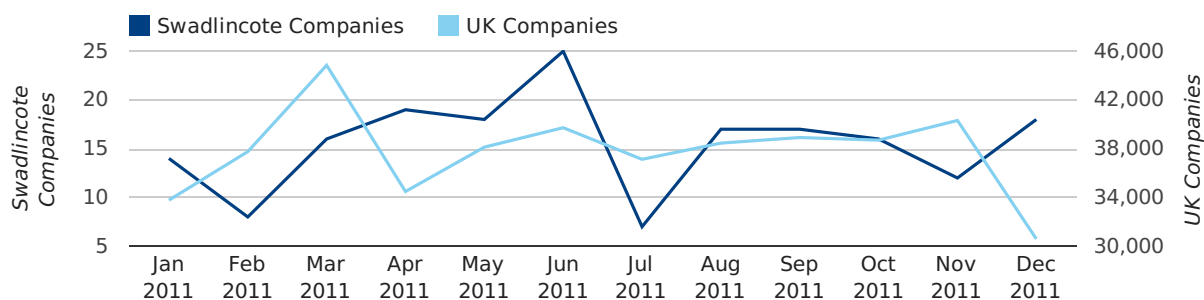
### new companies by quarter

### new companies by month



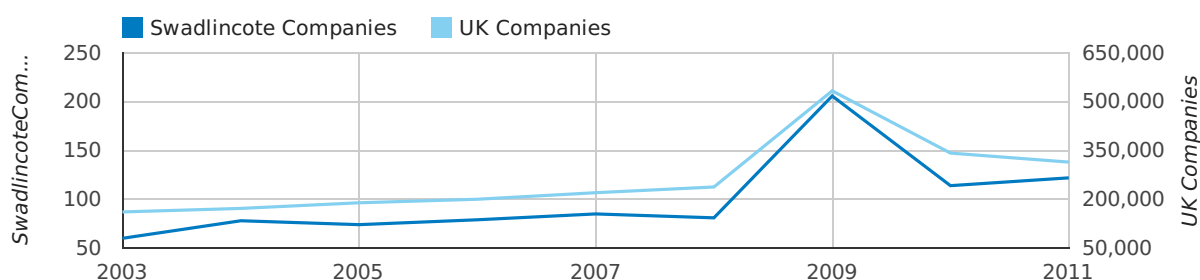

### dissolved companies by year



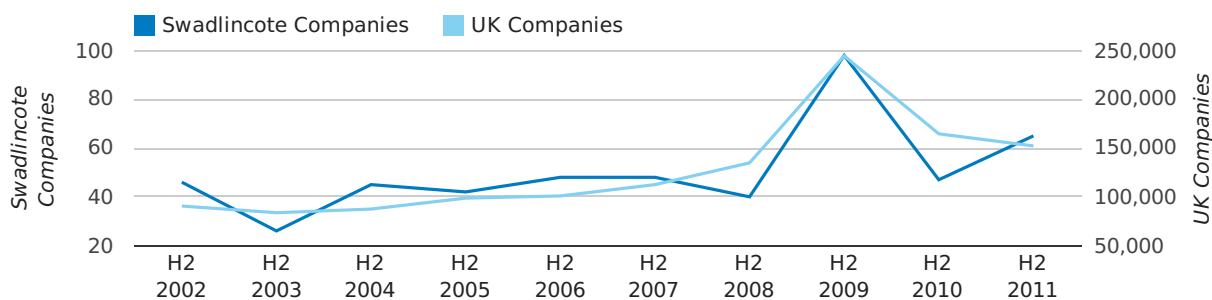
### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 65 companies were dissolved in Swadlincote. This figure is 38.3% higher than last year, which compares badly to the UK wide change of -7.5%.

### dissolved companies by half year



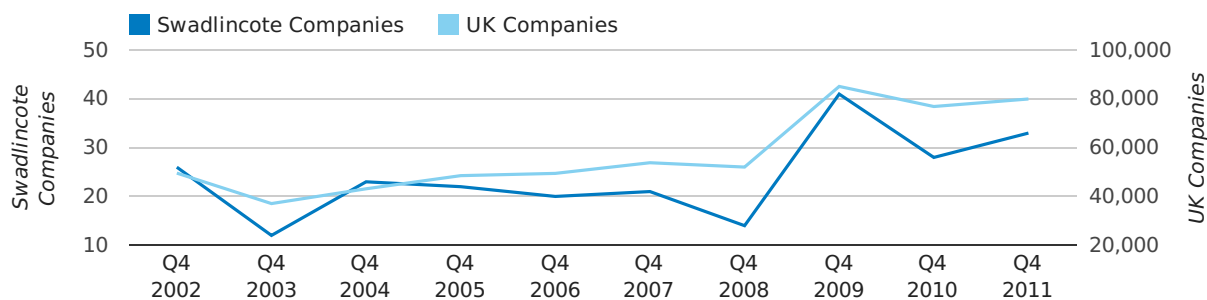
## Quarterly Data (Q4 Oct-Dec 2011)

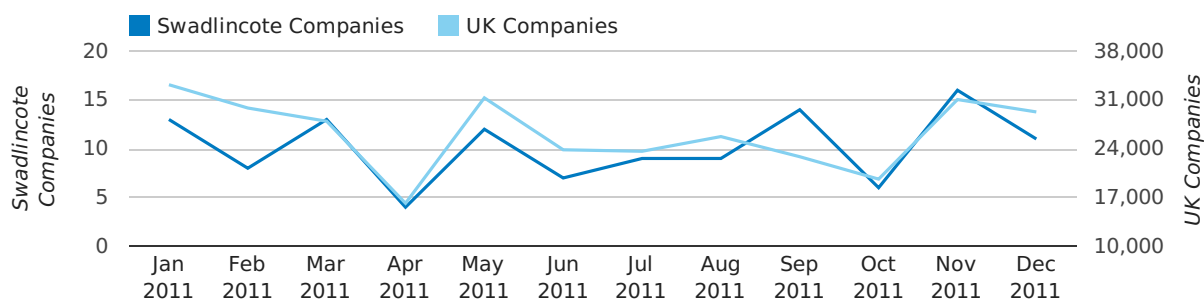
### dissolved companies by quarter

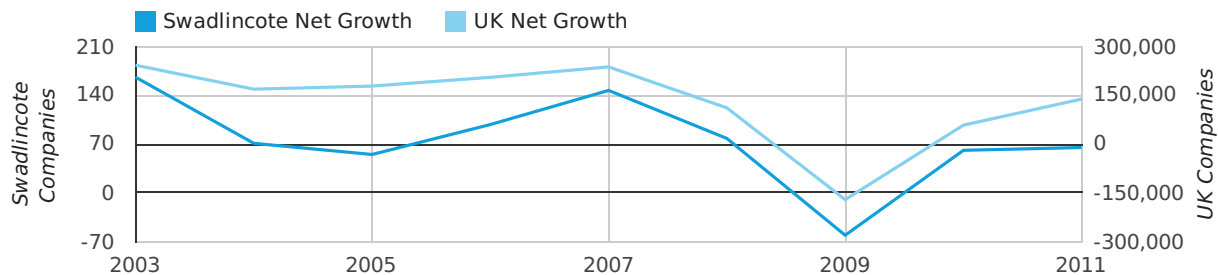
A total of 65 companies were added to the company register for Swadlincote in 2011. This number represents growth of 37.1% which compares favourably to the UK figure of 34.6%.

### net growth by year

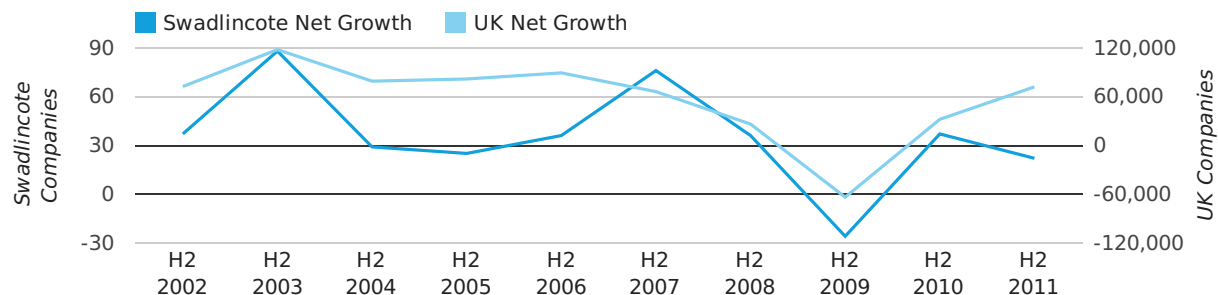


### Half Year Data (Jul-Dec 2011)

### net growth by half year



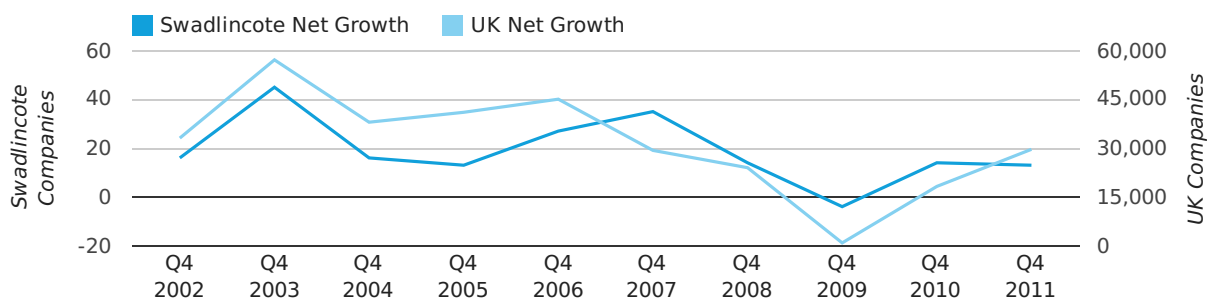

This represents a decrease of 7.1% on the same period last year.

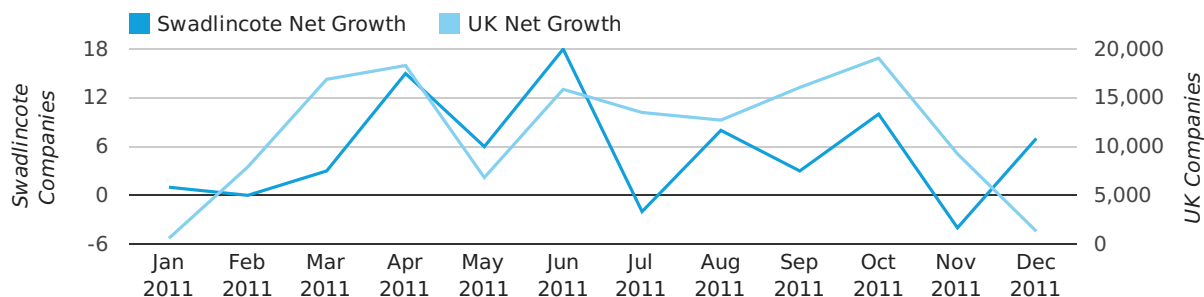

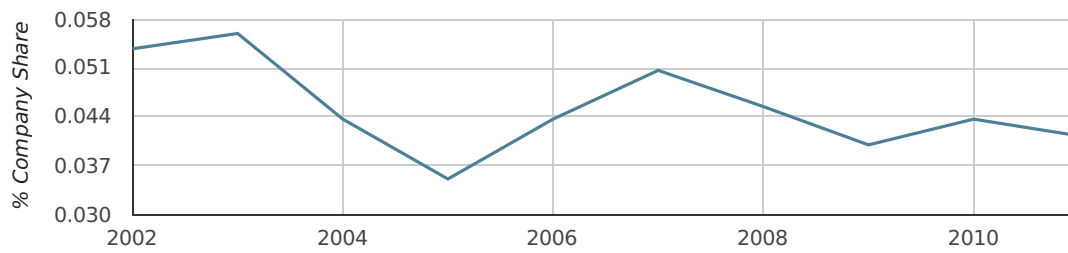

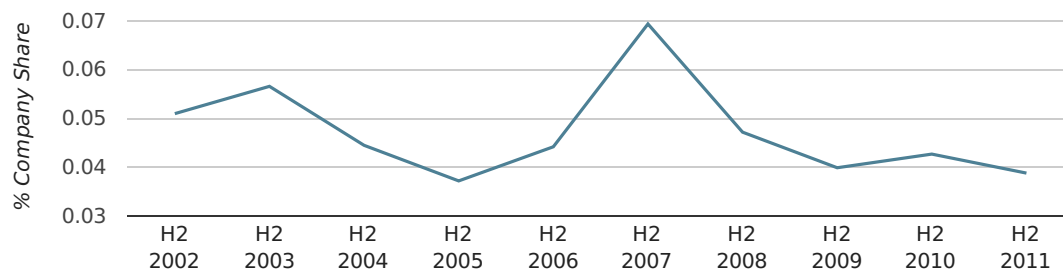

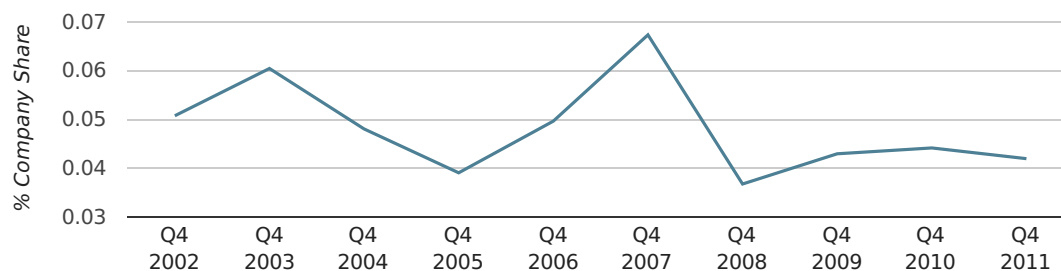

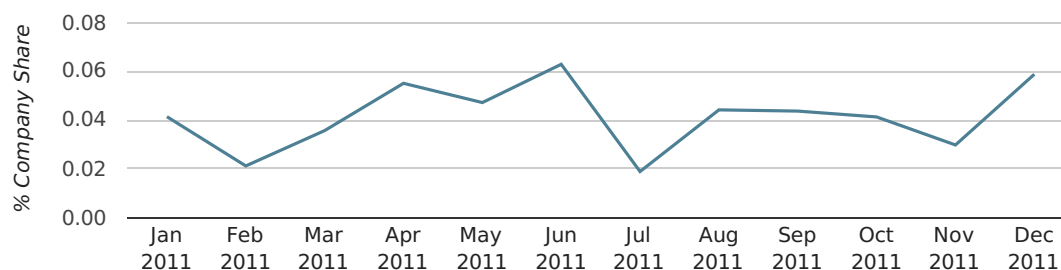

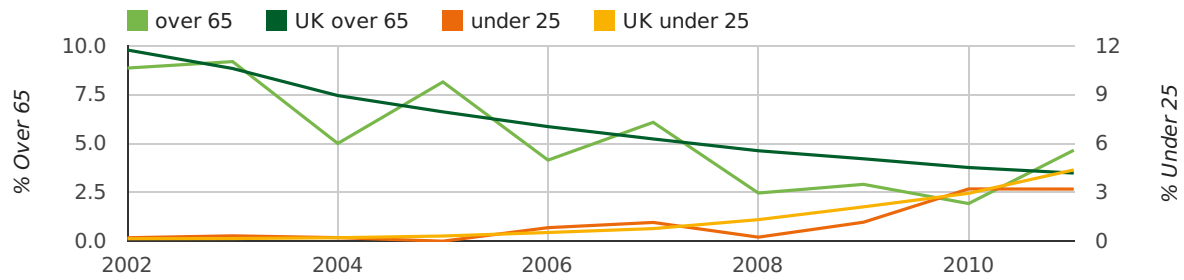

#### director age by year



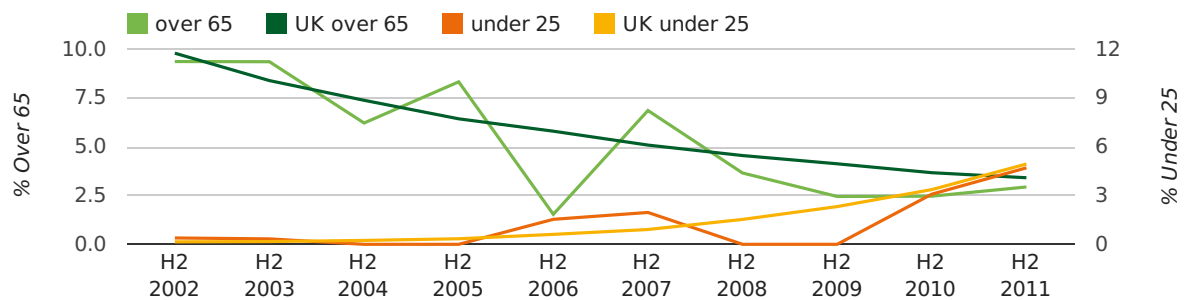

#### director age by half year



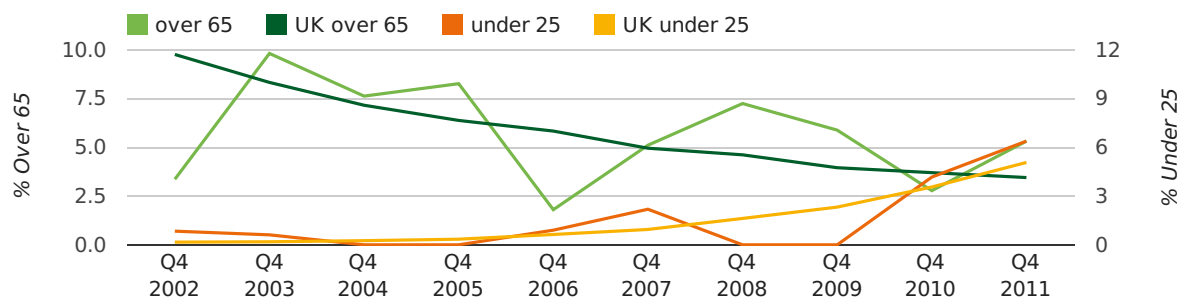

### director age by quarter

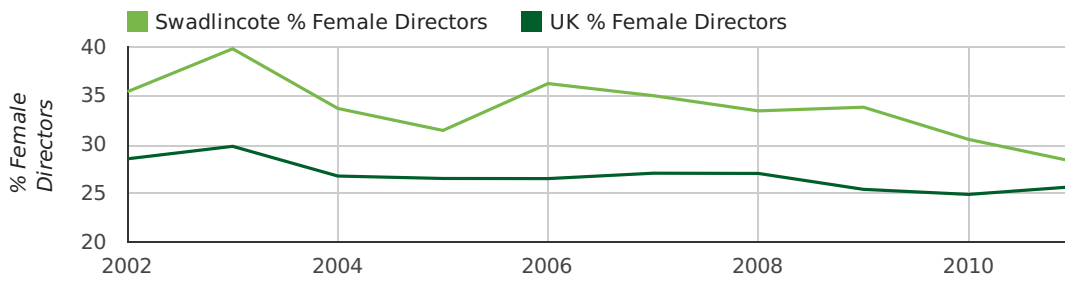


### Annual Data (2011)

#### director gender by year

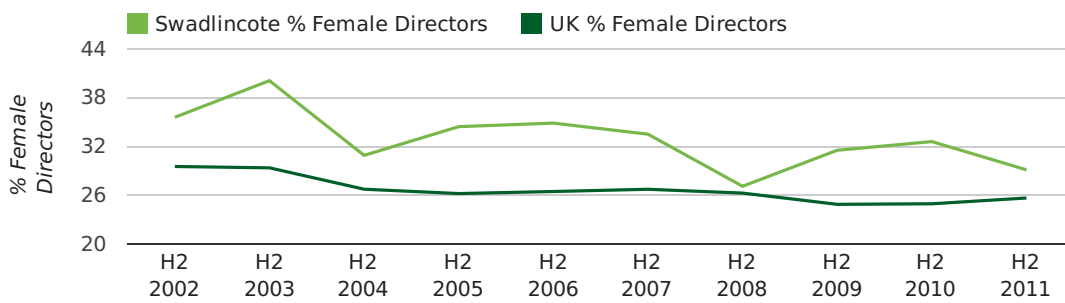


### Half Year Data (Jul-Dec 2011)

#### director gender by half year

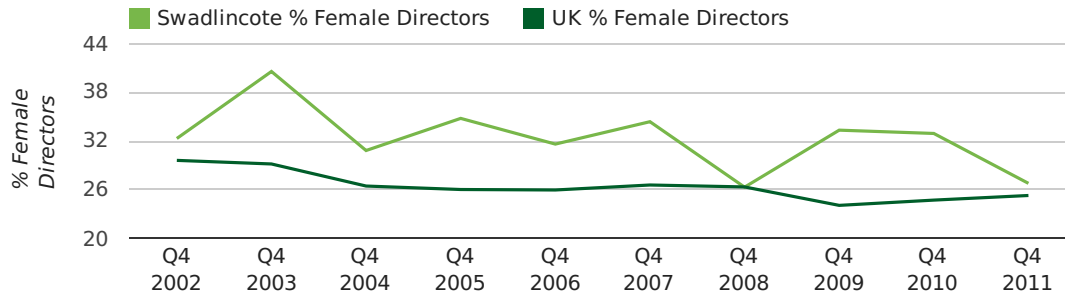


## Quarterly Data (Q4 Oct-Dec 2011)
