The first half of 2012 saw a new record in company registrations in Swansea when compared to any previous first half year.


The first half of 2012 was a record first half year for company registrations in Swansea when compared to any half year in history.

In the first half of 2012 a total of 593 companies were formed in Swansea. This figure is 17.2% higher than last year, which compares well to the UK wide figure of 10.7%.

new companies by half year




Quarterly Data (Q2 Apr-Jun 2012)





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)



net growth by half year





net growth by quarter





company share by half year







director age by half year






director age by quarter
