


In the first half of 2011 a total of 663 companies were formed in Swindon. This figure is 15.1% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Swindon occurred in 2006 when a total of 728 were formed.

#### new companies by half year




#### Quarterly Data (Q2 Apr-Jun 2011)

A total of 325 companies were registered in Swindon during the second quarter of 2011 (Apr 2011 - Jun 2011).

This figure is an increase of 15.2% versus the same period last year (Q2 2010). This figure compares well to the UK as a whole, which saw an increase of 13.9% against the same period last year.





#### dissolved companies by half year





A total of 162 companies were dissolved in Swindon during the second quarter of 2011 (Apr 2011 - Jun 2011).





#### net growth by half year





This represents an increase of 16,200.0% on the same period last year.











#### director age by half year




