




Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 600 companies were formed in Swindon. This figure is 6.2% higher than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Swindon occurred in 2006 when a total of 689 were formed.


new companies by half year





dissolved companies by year




Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 392 companies were dissolved in Swindon. This figure is 22.2% lower than last year, which compares well to the UK wide change of -7.5%.

The highest total for a second half year in Swindon occurred in 2009 when a total of 795 were closed.




A total of 222 companies were dissolved in Swindon during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 439 companies were added to the company register for Swindon in 2011. This number represents growth of 38.5% which compares favourably to the UK figure of 34.6%.



net growth by half year




Net company growth for Swindon during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 77 companies.






company share by year




company share by half year





director age by year





director gender by year




Half Year Data (Jul-Dec 2011)
