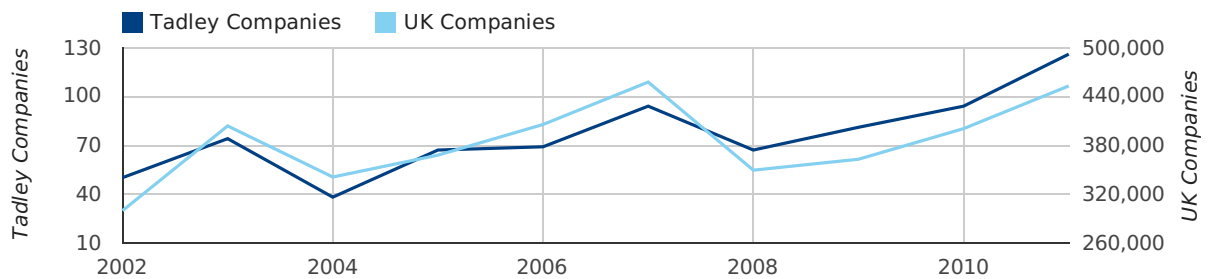
Annual Data (2011)

2011 was a record year for company registrations in Tadley when compared to any year in history.

A total of 126 companies were formed in Tadley in 2011. This total is 34.0% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

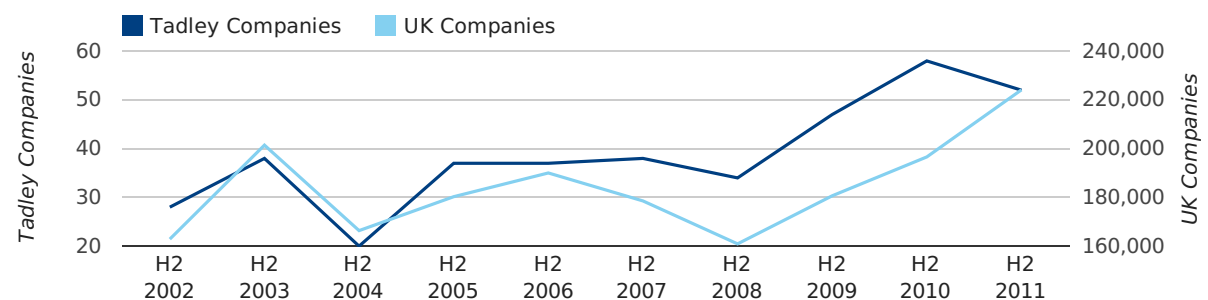
Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 52 companies were formed in Tadley. This figure is 10.3% lower than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Tadley occurred in 2010 when a total of 58 were formed.

new companies by half year



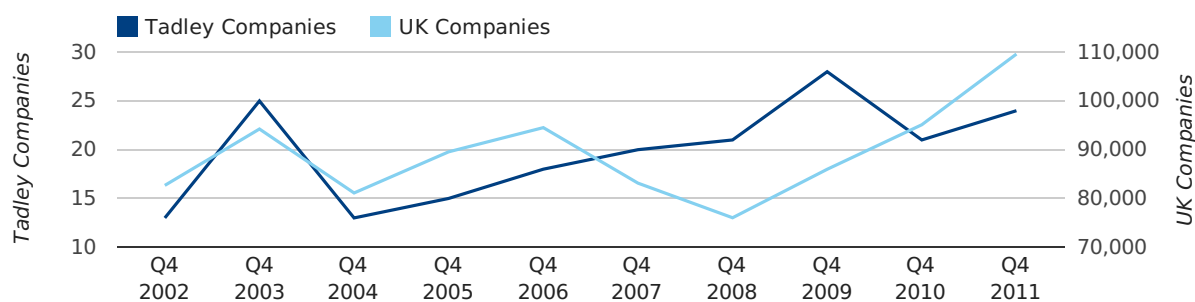
Quarterly Data (Q4 Oct-Dec 2011)

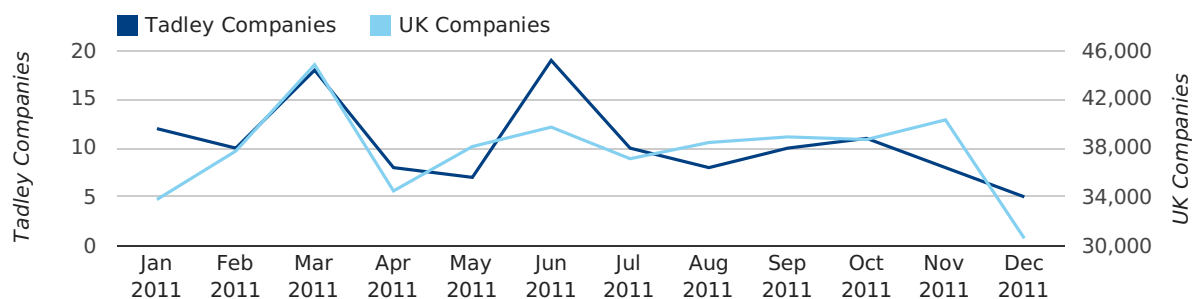

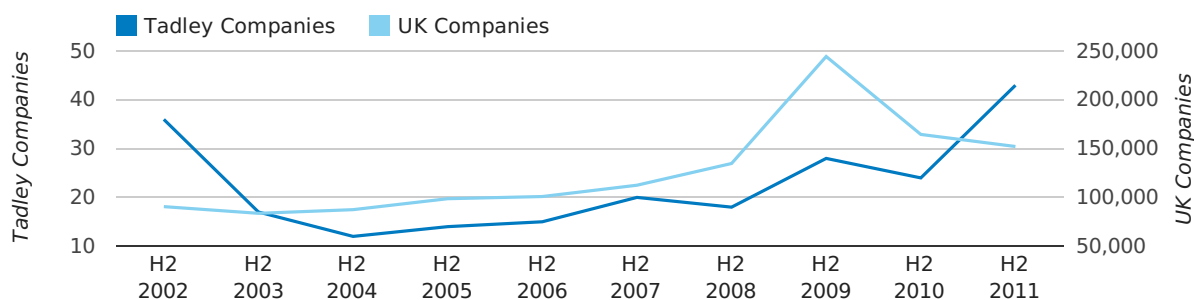
The second half of 2011 saw a new record in company closures in Tadley when compared to any previous second half year.

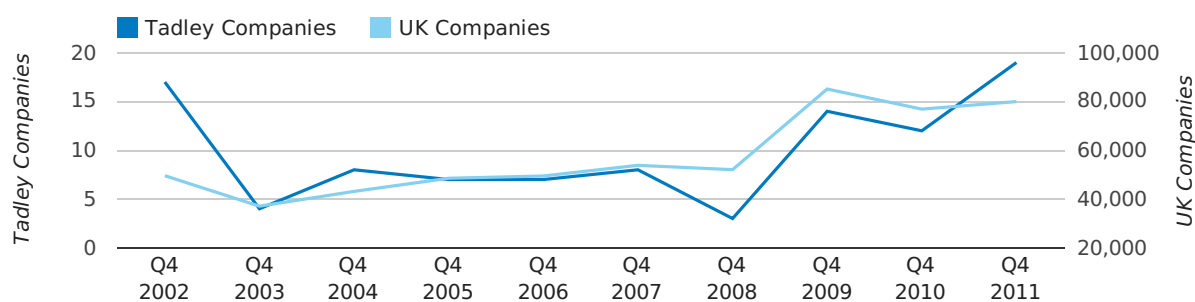
Q4 2011 saw a new record in company closures in Tadley when compared to any previous Q4.

A total of 19 companies were dissolved in Tadley during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 58.3% versus the same period last year (Q4 2010). This figure compares poorly to the UK as a whole, which saw an increase of 4.0% against the same period last year.

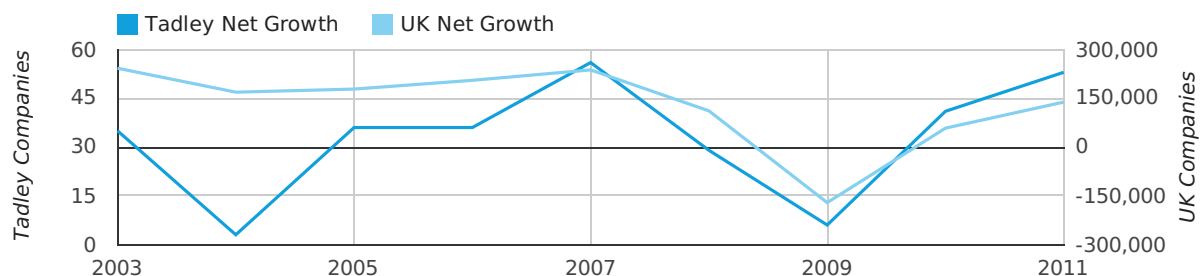
A total of 53 companies were added to the company register for Tadley in 2011. This number represents growth of 56.4% which compares favourably to the UK figure of 34.6%.

net growth by year

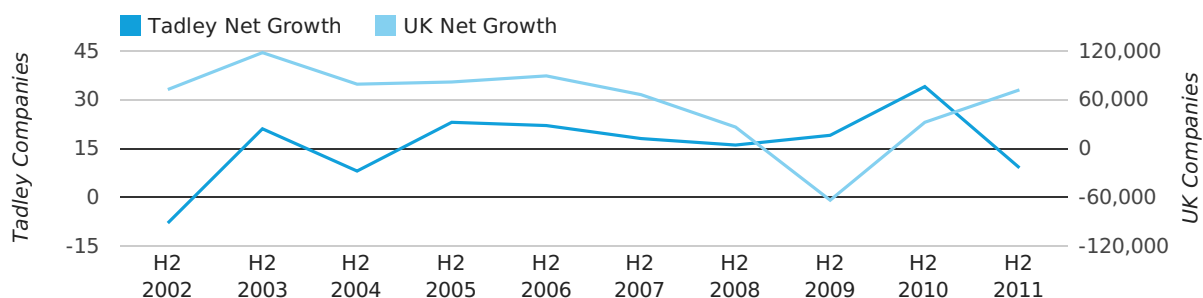


Half Year Data (Jul-Dec 2011)

net growth by half year



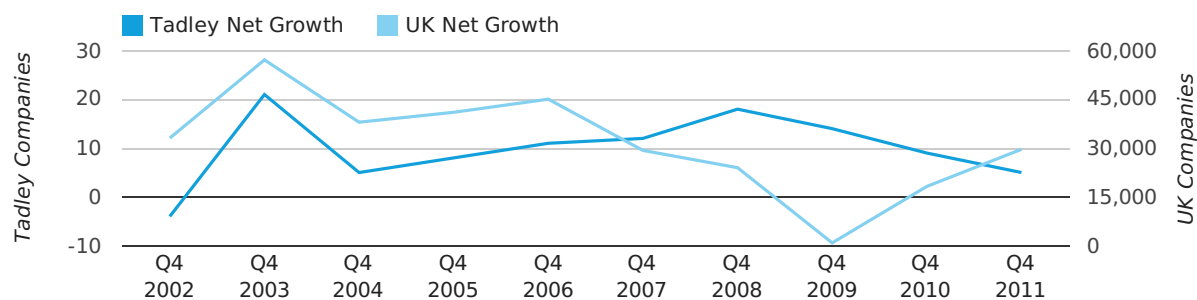

This represents a decrease of 44.4% on the same period last year.

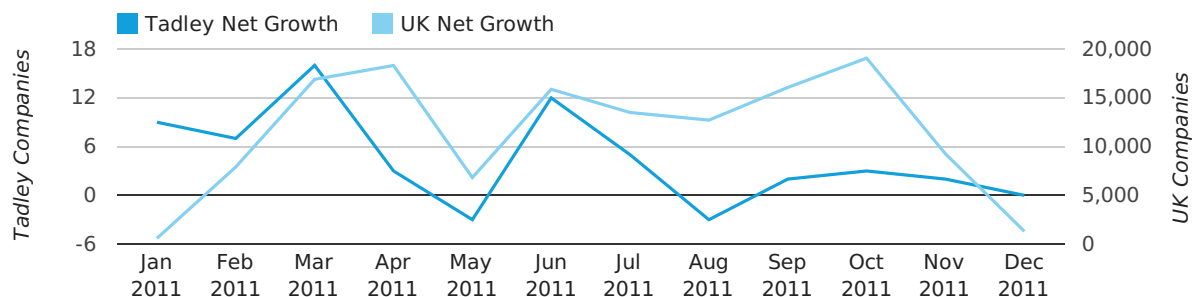

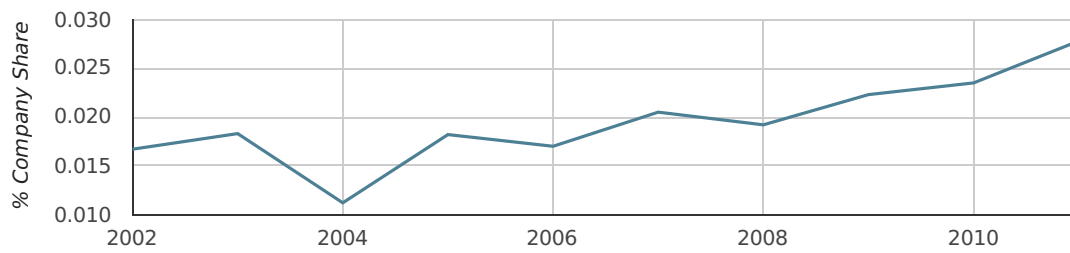

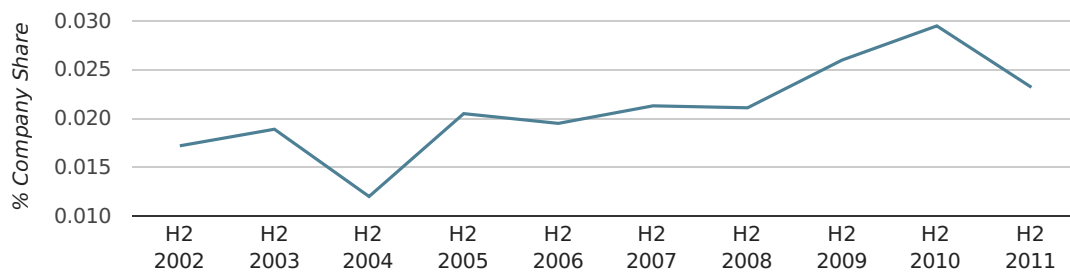

company share by half year

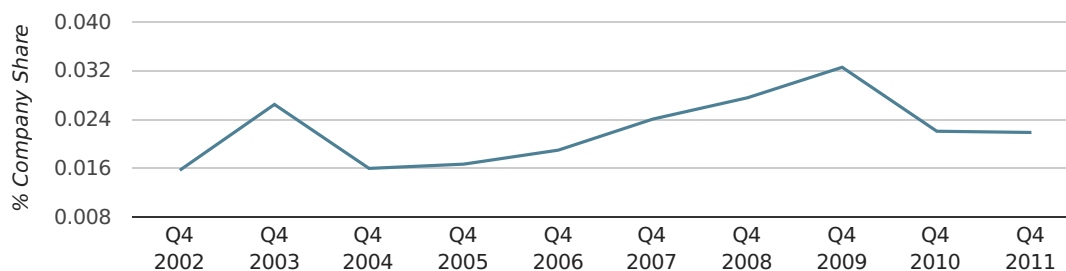

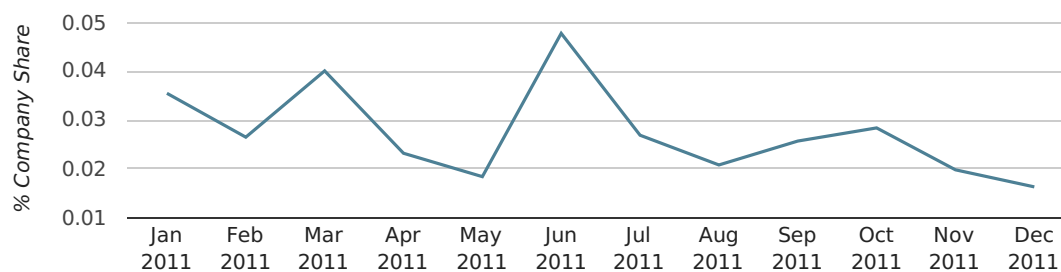

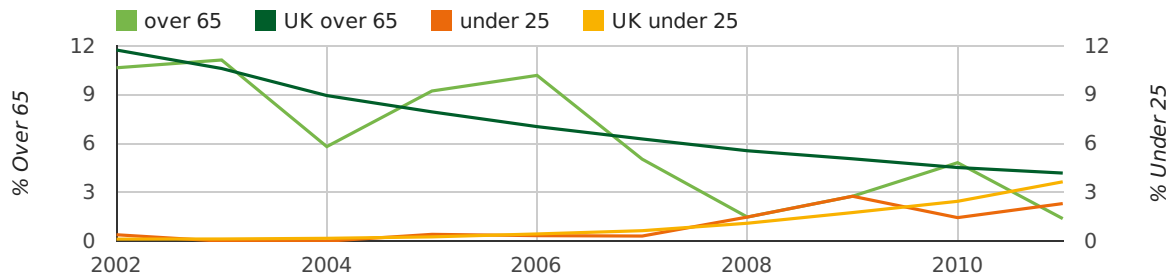

director age by year



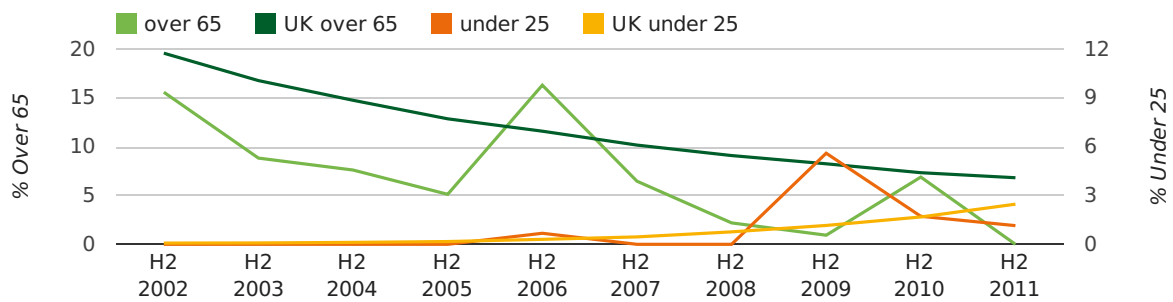

director age by half year



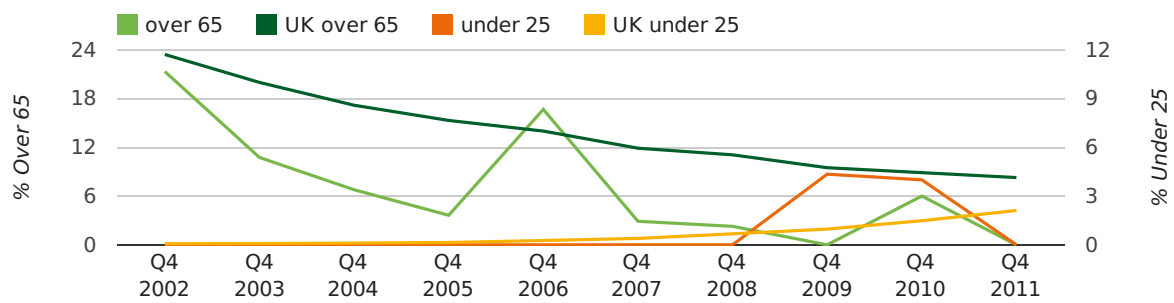

director age by quarter

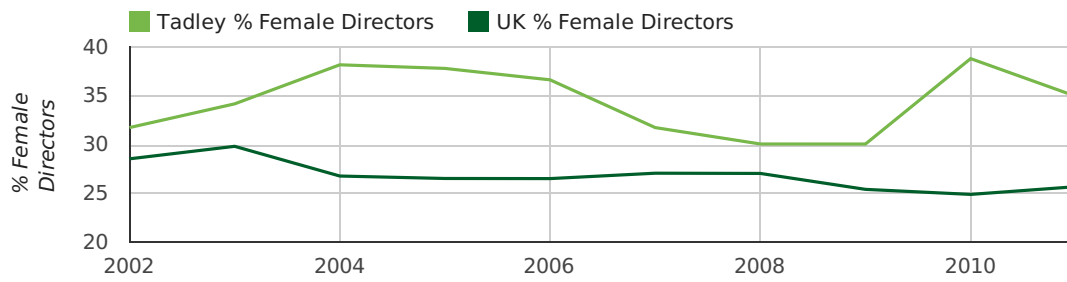


Annual Data (2011)

director gender by year

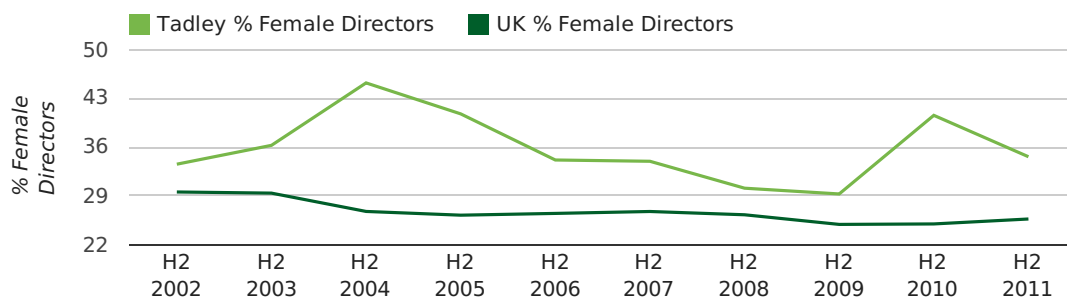


Half Year Data (Jul-Dec 2011)

director gender by half year

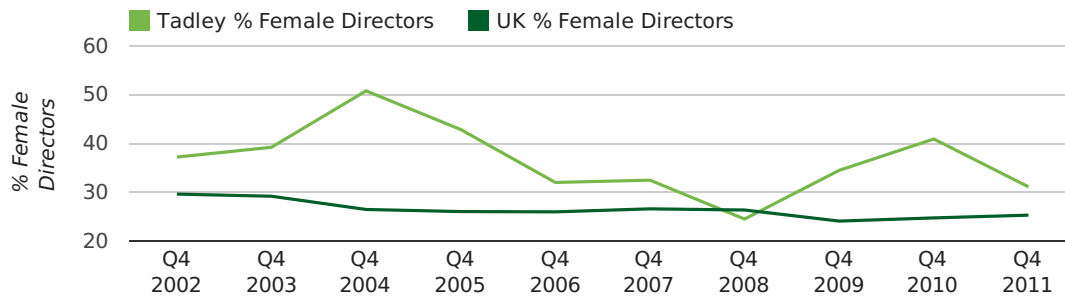


Quarterly Data (Q4 Oct-Dec 2011)
