




Half Year Data (Jul-Dec 2011)




new companies by half year






Q4 2011 saw a new record in company closures in Tadworth when compared to any previous Q4.




A total of 31 companies were added to the company register for Tadworth in 2011. This number represents growth of 23.5% which compares unfavourably to the UK figure of 34.6%.





net growth by quarter






company share by year







director age by year




director age by half year

23.2% of all director appointments in Tadworth in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


