The first half of 2012 saw a new record in company registrations in Taunton when compared to any previous first half year.


The first half of 2012 was a record first half year for company registrations in Taunton when compared to any half year in history.

In the first half of 2012 a total of 311 companies were formed in Taunton. This figure is 23.4% higher than last year, which compares well to the UK wide figure of 10.7%.

The highest total for a first half year in Taunton occurred in 2012 when a total of 311 were formed.


Q2 2012 saw a new record in company registrations in Taunton when compared to any previous Q2.





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)





net growth by half year









company share by half year







director age by half year






director age by quarter
