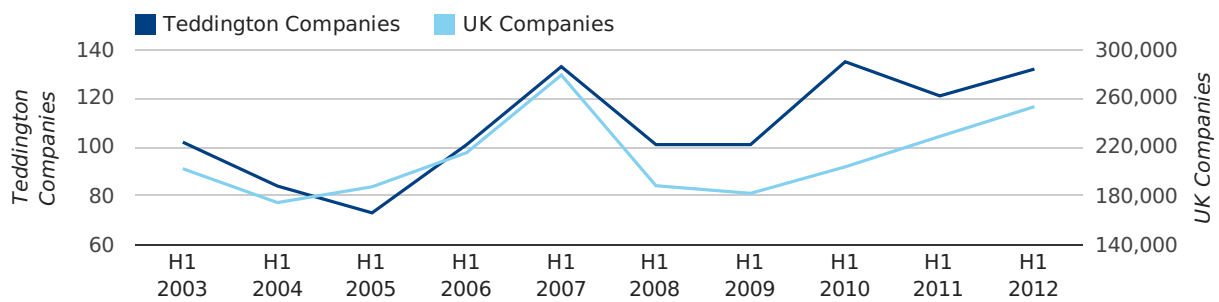
Half Year Data (Jan-Jun 2012)

In the first half of 2012 a total of 132 companies were formed in Teddington. This figure is 9.1% higher than last year, which compares badly to the UK wide figure of 10.7%.

The highest total for a first half year in Teddington occurred in 2010 when a total of 135 were formed.

new companies by half year



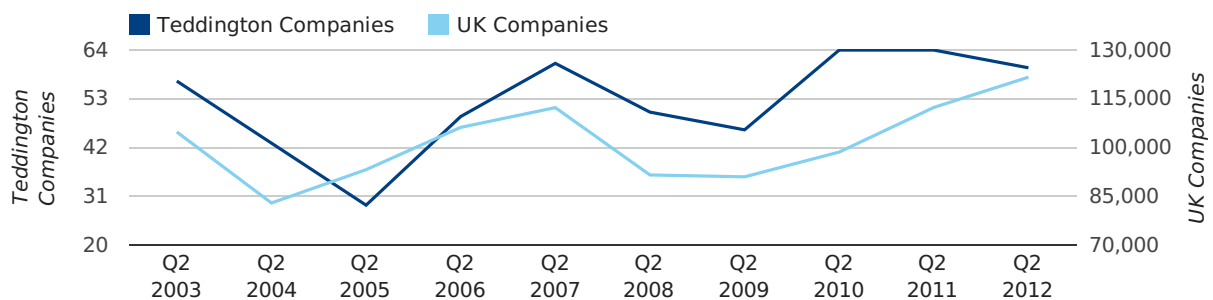
Quarterly Data (Q2 Apr-Jun 2012)

This figure is a decrease of 6.3% versus the same period last year (Q2 2011). This figure compares badly to the UK as a whole, which saw an increase of 8.3% against the same period last year.

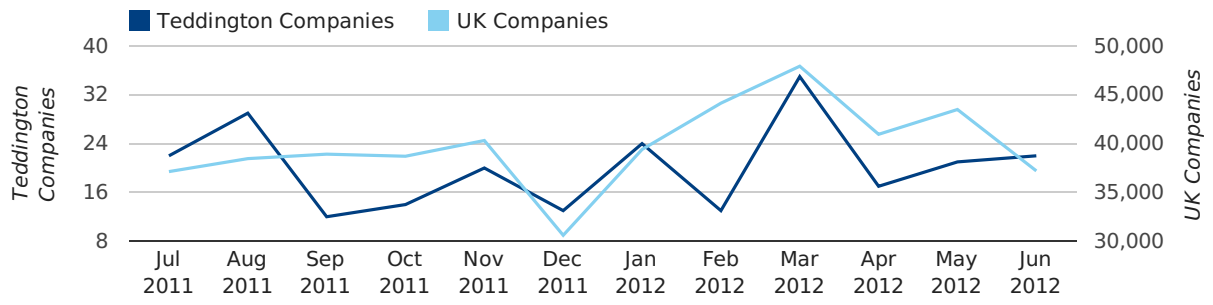

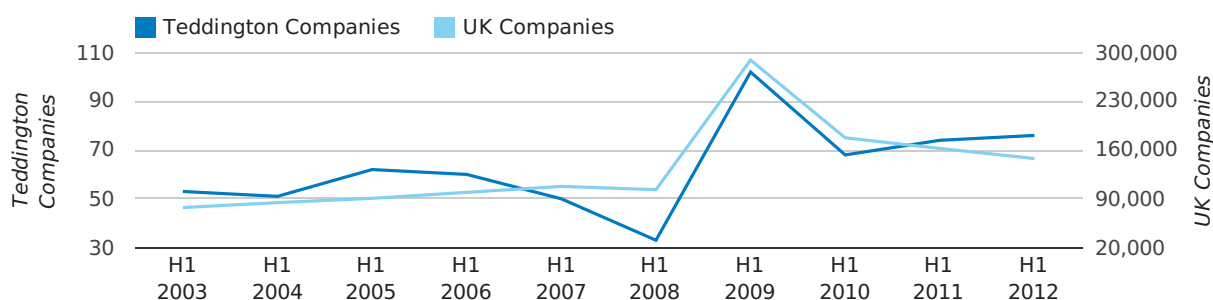
Half Year Data (Jan-Jun 2012)

In the first half of 2012 a total of 76 companies were dissolved in Teddington. This figure is 2.7% higher than last year, which compares badly to the UK wide change of -8.9%.

The highest total for a first half year in Teddington occurred in 2009 when a total of 102 were closed.

dissolved companies by half year



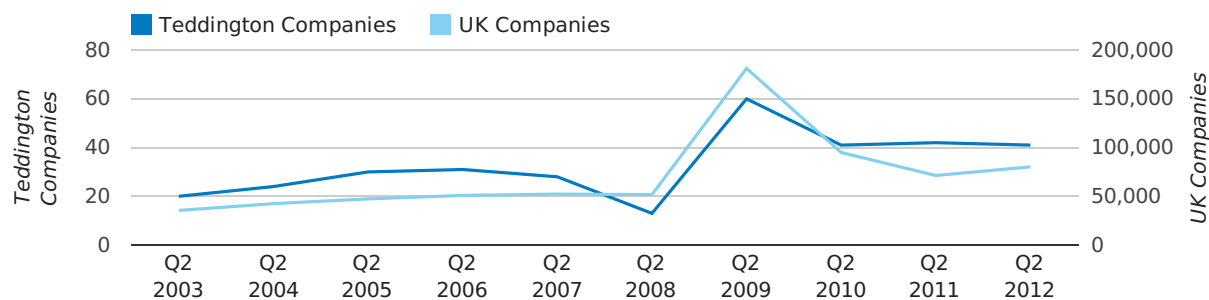
Quarterly Data (Q2 Apr-Jun 2012)

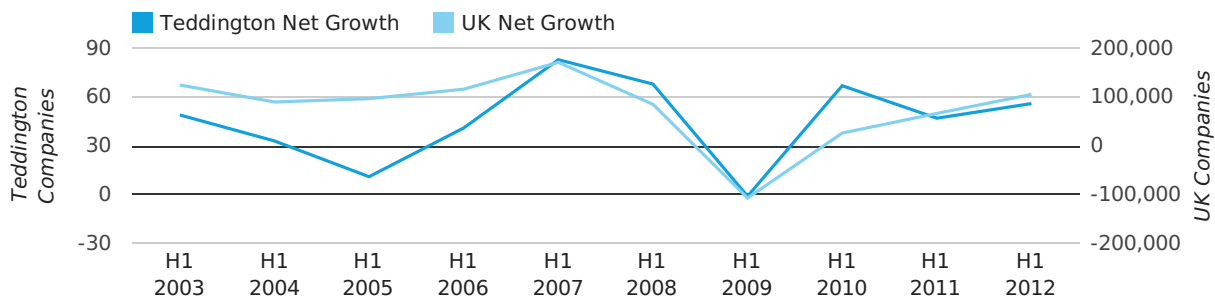

net growth by half year



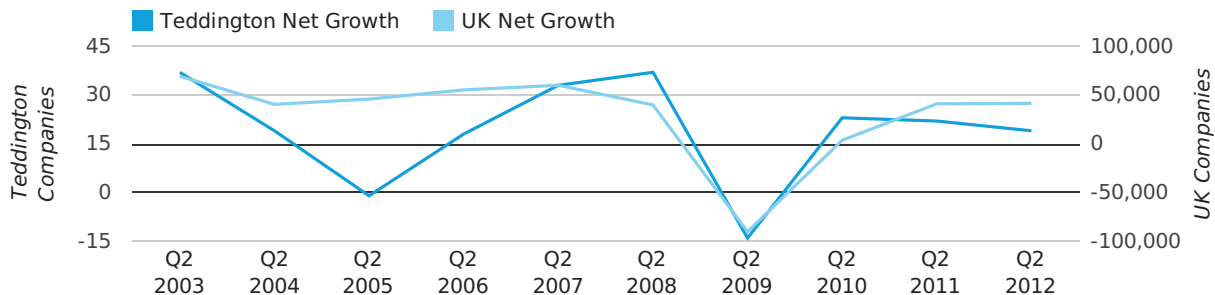
Quarterly Data (Q2 Apr-Jun 2012)

This represents a decrease of 13.6% on the same period last year.

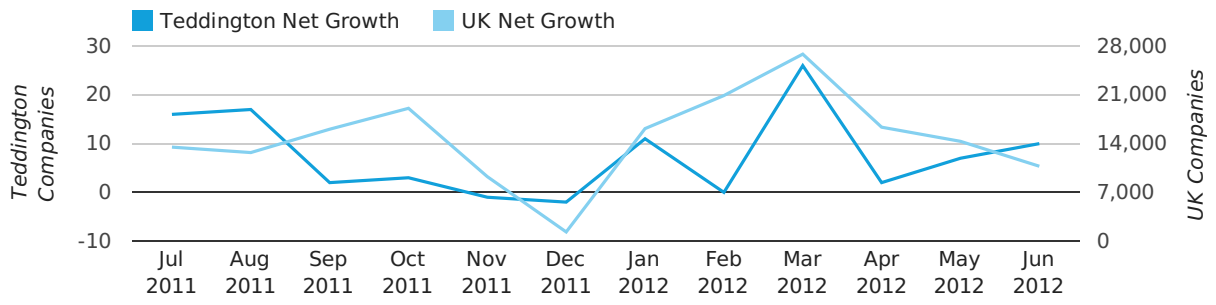

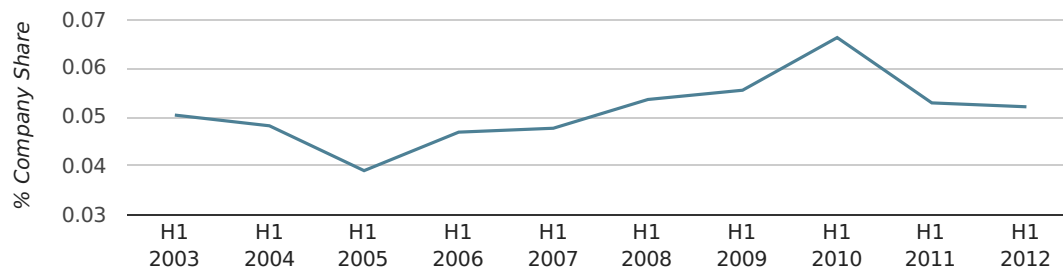

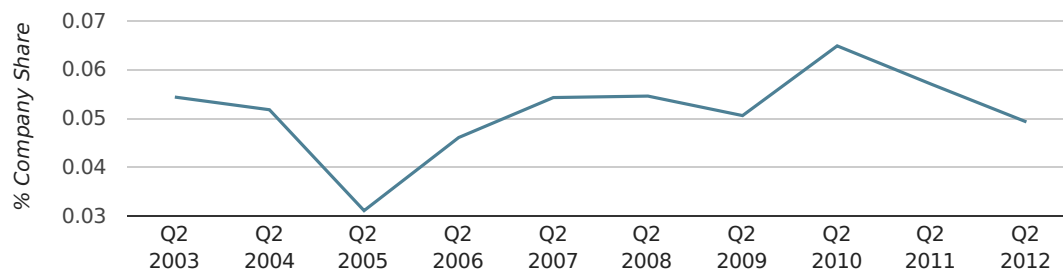

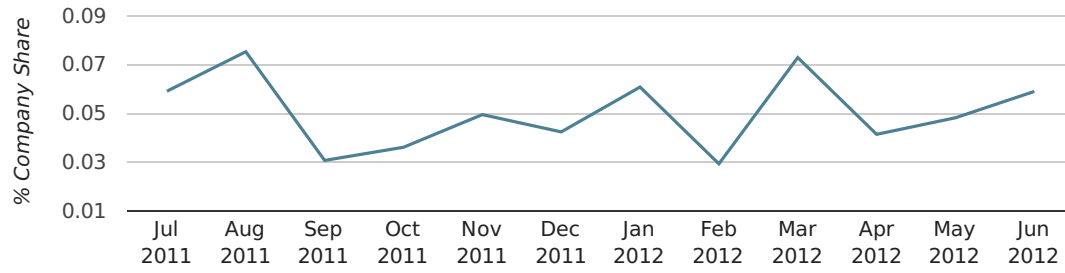

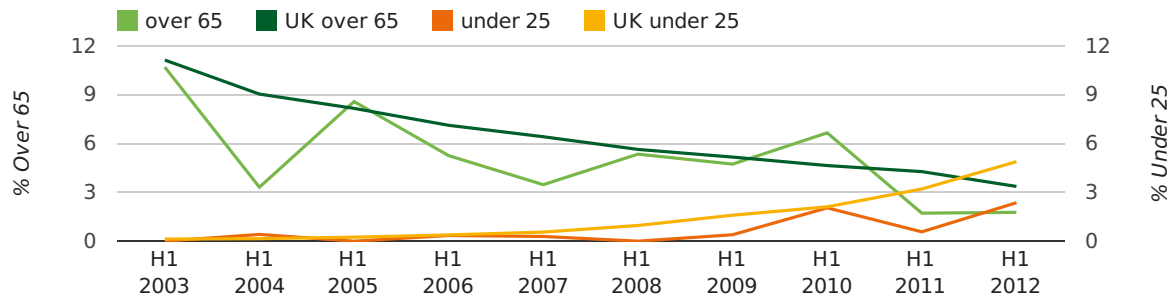

director age by half year



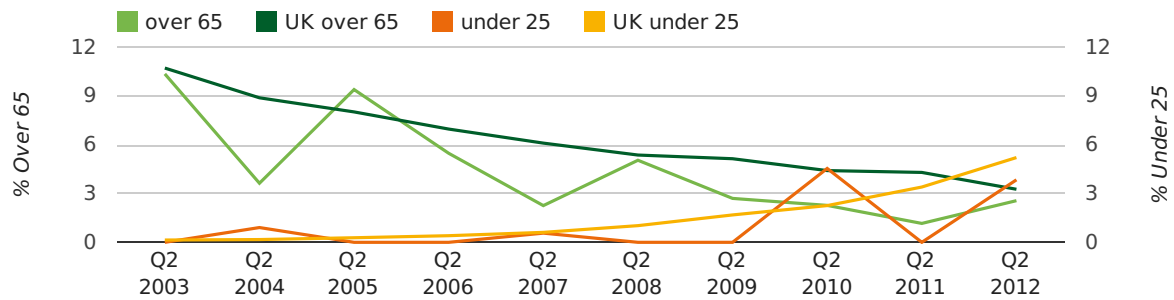
Quarterly Data (Q2 Apr-Jun 2012)

director age by quarter

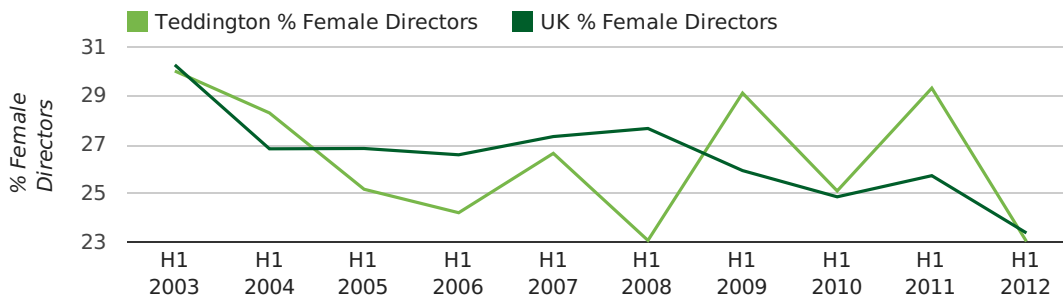


Half Year Data (Jan-Jun 2012)

The record first half year for female directors in Teddington was 1861 when 40.0% of all directors were female.

23.0% of all director appointments in Teddington in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.

director gender by half year

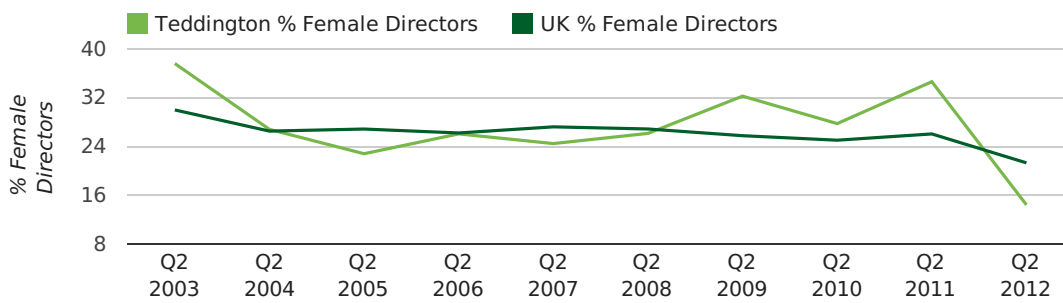


Quarterly Data (Q2 Apr-Jun 2012)

The record second quarter for female directors in Teddington was in 1866 when 66.7% of all directors were female.
