




#### Half Year Data (Jul-Dec 2011)


#### new companies by half year






A total of 15 companies were dissolved in Thame during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 43 companies were added to the company register for Thame in 2011. This number represents growth of 29.9% which compares unfavourably to the UK figure of 34.6%.

#### net growth by year



net growth by half year




#### net growth by quarter

#### net growth by month






company share by year







The percentage of directors over the age of 65 was 8.1% compared to the UK figure of 4.1%.


#### director age by quarter

#### director gender by year




## Half Year Data (Jul-Dec 2011)
