




## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 52 companies were formed in Thames Ditton. This figure is 23.8% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Thames Ditton occurred in 2003 when a total of 59 were formed.





dissolved companies by year




## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 34 companies were dissolved in Thames Ditton. This figure is 30.6% lower than last year, which compares well to the UK wide change of -7.5%.

## dissolved companies by half year




A total of 17 companies were dissolved in Thames Ditton during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 53 companies were added to the company register for Thames Ditton in 2011. This number represents growth of 50.5% which compares favourably to the UK figure of 34.6%.




## Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Thames Ditton during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 12 companies.




company share by year




#### company share by quarter



The percentage of directors over the age of 65 was 8.1% compared to the UK figure of 4.1%.





#### director age by quarter





#### director gender by year




## Half Year Data (Jul-Dec 2011)

38.8% of all director appointments in Thames Ditton in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.
