


Half Year Data (Jul-Dec 2011)




A total of 41 companies were registered in Thornton-Cleveleys during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)




A total of 24 companies were dissolved in Thornton-Cleveleys during the fourth quarter of 2011 (Oct 2011 - Dec 2011).







net growth by half year





net growth by month








company share by half year





director age by year





director age by half year




director age by quarter

director gender by year



director gender by half year


