




#### dissolved companies by quarter

#### dissolved companies by month







#### net growth by month








## Quarterly Data (Q1 Jan-Mar 2011)

The percentage of directors over the age of 65 was 9.5% compared to the UK figure of 4.3%.


#### director age by quarter
