


2011 was a record year for company registrations in Tring when compared to any year in history.

A total of 176 companies were formed in Tring in 2011. This total is 1.1% higher than in 2010 and compares favourably to the UK figure of a 13.1% growth compared to 400,358 the previous year.


Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 79 companies were formed in Tring. This figure is 2.6% higher than last year, which compares badly to the UK wide figure of 14.0%.

new companies by half year




A total of 41 companies were registered in Tring during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


new companies by quarter

new companies by month



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 27 companies were dissolved in Tring during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter


A total of 61 companies were added to the company register for Tring in 2011. This number represents growth of 35.1% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Tring during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 14 companies.


net growth by quarter

net growth by month






company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)
