




## Quarterly Data (Q2 Apr-Jun 2011)



#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2011)




Net company growth for Truro during the second quarter of 2011 (Apr 2011 - Jun 2011) was 72 companies.







#### director age by half year





The percentage of directors over the age of 65 was 9.0% compared to the UK figure of 4.3%.






The record first half year for female directors in Truro was 1861 when 40.0% of all directors were female.

28.5% of all director appointments in Truro in the first half of 2011 were female. This compares to a UK average of 25.7% for the same period.


#### director gender by half year
