

#### new companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 216 companies were formed in Truro. This figure is 4.3% higher than last year, which compares badly to the UK wide figure of 14.0%.

#### new companies by half year




A total of 94 companies were registered in Truro during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





The second half of 2011 saw a new record in company closures in Truro when compared to any previous second half year.


The second half of 2011 was a record second half year for company closures in Truro when compared to any half year in history.

Q4 2011 saw a new record in company closures in Truro when compared to any previous Q4.


Q4 2011 was a record quarter for company closures in Truro when compared to any quarter in history.

A total of 100 companies were dissolved in Truro during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 104.1% versus the same period last year (Q4 2010). This figure compares poorly to the UK as a whole, which saw an increase of 4.0% against the same period last year.


#### dissolved companies by quarter


A total of 150 companies were added to the company register for Truro in 2011. This number represents growth of 32.3% which compares unfavourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Truro during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was -6 companies.

This represents a decrease of 112.2% on the same period last year.





#### company share by year




#### company share by half year





#### director age by year





#### director age by half year




The average age of a director in the fourth quarter of 2011 was 47.1.

The percentage of directors over the age of 65 was 5.4% compared to the UK figure of 4.1%.


#### director age by quarter

#### director gender by year




## Half Year Data (Jul-Dec 2011)
