




Quarterly Data (Q2 Apr-Jun 2012)

A total of 108 companies were registered in Truro during the second quarter of 2012 (Apr 2012 - Jun 2012).




The first half of 2012 saw a new record in company closures in Truro when compared to any previous first half year.


Q2 2012 saw a new record in company closures in Truro when compared to any previous Q2.












company share by half year





director age by half year






director age by quarter

27.2% of all director appointments in Truro in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.


director gender by half year
