
The first half of 2011 was a record first half year for company registrations in Uxbridge when compared to any half year in history.


Q2 2011 saw a new record in company registrations in Uxbridge when compared to any previous Q2.

new companies by quarter





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2011)





net growth by half year





This represents an increase of 533.3% on the same period last year.





company share by half year







director age by half year




