
Q3 2011 saw a new record in company registrations in Uxbridge when compared to any previous Q3.


#### new companies by month




Q3 2011 saw a new record in net growth in Uxbridge when compared to any previous Q3.


### net growth by month



The percentage of directors over the age of 65 was 2.6% compared to the UK figure of 4.1%.


#### director age by quarter
