

A total of 702 companies were formed in Uxbridge in 2011. This total is 19.2% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

The second half of 2011 saw a new record in company registrations in Uxbridge when compared to any previous second half year.


Q4 2011 saw a new record in company registrations in Uxbridge when compared to any previous Q4.





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 103 companies were dissolved in Uxbridge during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 293 companies were added to the company register for Uxbridge in 2011. This number represents growth of 49.7% which compares favourably to the UK figure of 34.6%.




Q4 2011 saw a new record in net growth in Uxbridge when compared to any previous Q4.


net growth by quarter

net growth by month






company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)

director gender by half year


