
The first half of 2012 saw a new record in company registrations in Uxbridge when compared to any previous first half year.


# Quarterly Data (Q2 Apr-Jun 2012)



#### net growth by half year








#### net growth by month


company share by half year





#### director age by half year





The percentage of directors over the age of 65 was 3.3% compared to the UK figure of 3.3%.


#### director age by quarter
