



A total of 215 companies were registered in Wakefield during the second quarter of 2012 (Apr 2012 - Jun 2012).





dissolved companies by half year





A total of 207 companies were dissolved in Wakefield during the second quarter of 2012 (Apr 2012 - Jun 2012).





net growth by half year









company share by half year







director age by half year






director age by quarter

director gender by half year


