The first half of 2012 saw a new record in company registrations in Wallington when compared to any previous first half year.


The first half of 2012 was a record first half year for company registrations in Wallington when compared to any half year in history.

In the first half of 2012 a total of 169 companies were formed in Wallington. This figure is 9.0% higher than last year, which compares badly to the UK wide figure of 10.7%.

The highest total for a first half year in Wallington occurred in 2012 when a total of 169 were formed.


Q2 2012 saw a new record in company registrations in Wallington when compared to any previous Q2.


new companies by quarter



dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)



net growth by half year







company share by half year







director age by half year






director age by quarter

director gender by half year


