




Half Year Data (Jul-Dec 2011)


new companies by half year










A total of 58 companies were added to the company register for Waltham Abbey in 2011. This number represents growth of 43.9% which compares favourably to the UK figure of 34.6%.




Half Year Data (Jul-Dec 2011)

net growth by half year




Q4 2011 saw a new record in net growth in Waltham Abbey when compared to any previous Q4.

net growth by quarter






company share by year





director age by year




director age by half year

director age by quarter





director gender by year




Half Year Data (Jul-Dec 2011)

21.6% of all director appointments in Waltham Abbey in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


director gender by half year
