

## Half Year Data (Jul-Dec 2011)


The second half of 2011 saw a new record in company registrations in Waltham Cross when compared to any previous second half year.




Q4 2011 saw a new record in company registrations in Waltham Cross when compared to any previous Q4.



December 2011 saw a new record in company registrations in Waltham Cross when compared to any previous December.





dissolved companies by year




# Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 119 companies were dissolved in Waltham Cross. This figure is 13.1% lower than last year, which compares well to the UK wide change of -7.5%.

The highest total for a second half year in Waltham Cross occurred in 2005 when a total of 247 were closed.

## dissolved companies by half year




A total of 58 companies were dissolved in Waltham Cross during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 169 companies were added to the company register for Waltham Cross in 2011. This number represents growth of 47.7% which compares favourably to the UK figure of 34.6%.




## Half Year Data (Jul-Dec 2011)




Net company growth for Waltham Cross during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 37 companies.

#### net growth by quarter






company share by year







#### director age by year





#### director gender by year




# Half Year Data (Jul-Dec 2011)

25.2% of all director appointments in Waltham Cross in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


#### director gender by half year
