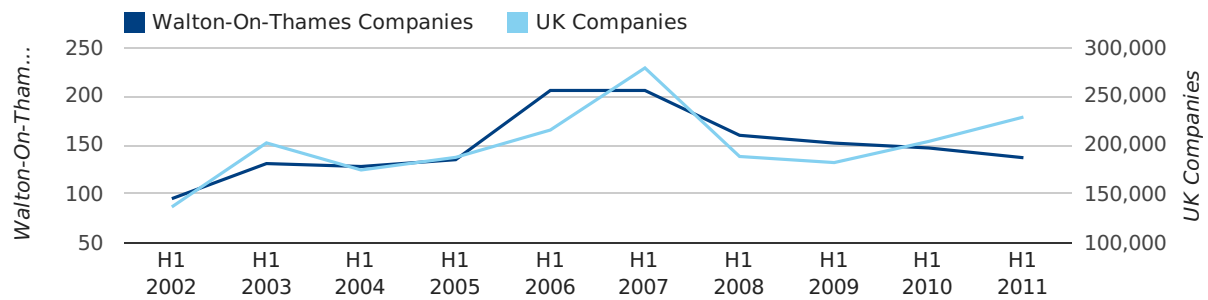
Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 137 companies were formed in Walton-On-Thames. This figure is 6.8% lower than last year, which compares badly to the UK wide figure of 12.3%.

The highest total for a first half year in Walton-On-Thames occurred in 2006 when a total of 206 were formed.

new companies by half year



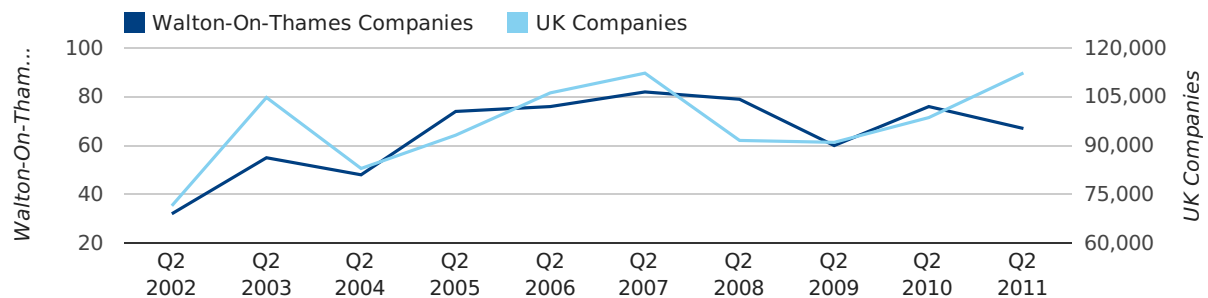
Quarterly Data (Q2 Apr-Jun 2011)

This figure is a decrease of 11.8% versus the same period last year (Q2 2010). This figure compares badly to the UK as a whole, which saw an increase of 13.9% against the same period last year.

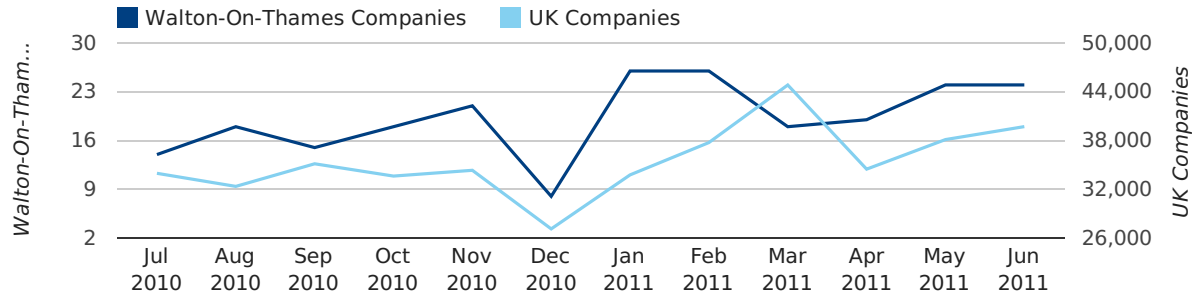

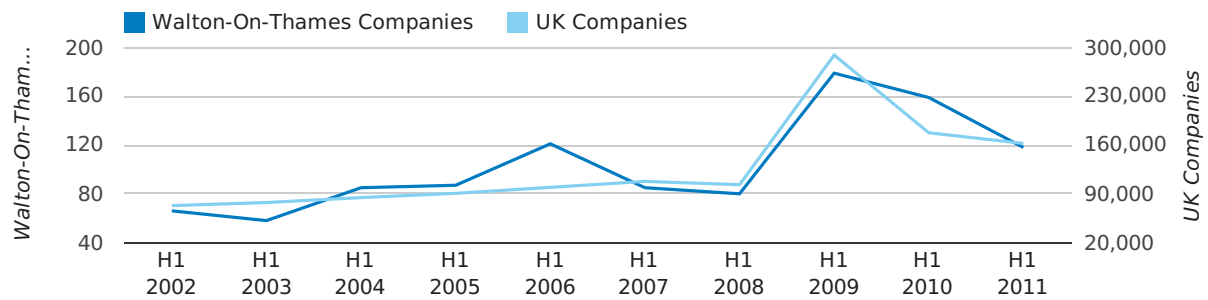
Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 118 companies were dissolved in Walton-On-Thames. This figure is 25.8% lower than last year, which compares well to the UK wide change of -8.6%.

The highest total for a first half year in Walton-On-Thames occurred in 2009 when a total of 179 were closed.

dissolved companies by half year



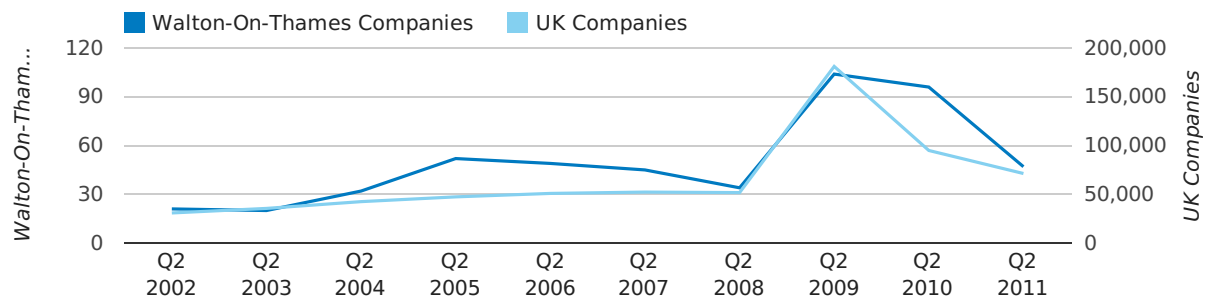
Quarterly Data (Q2 Apr-Jun 2011)

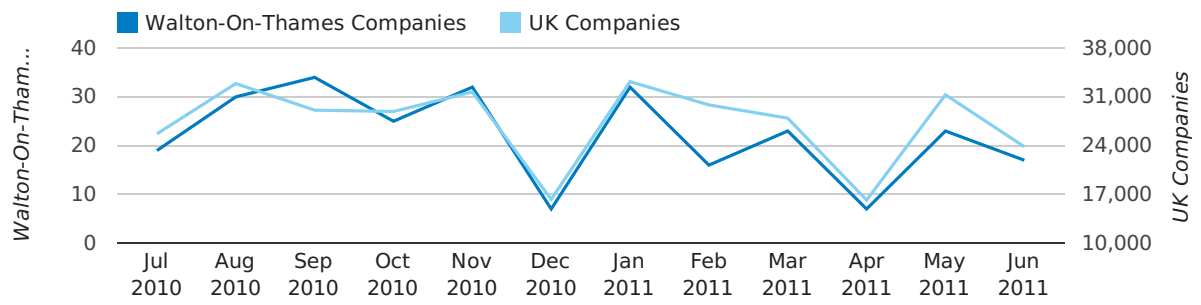

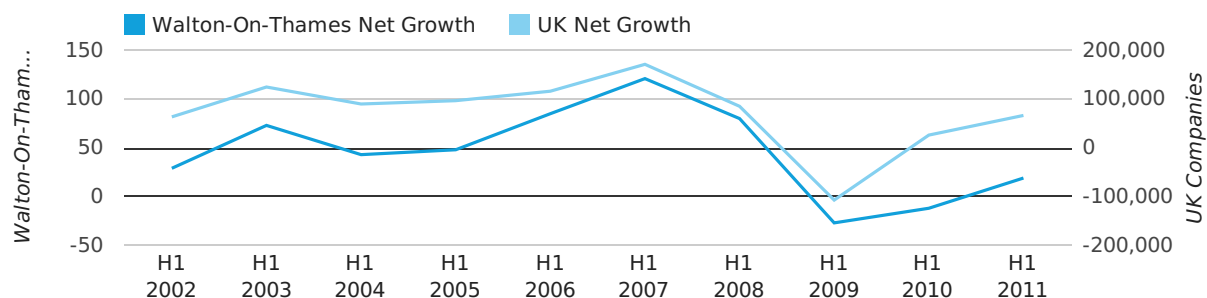

net growth by half year



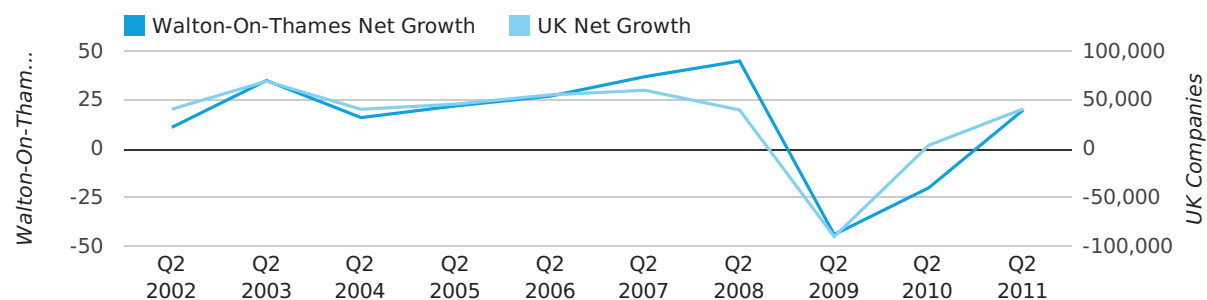

This represents an increase of 200.0% on the same period last year.

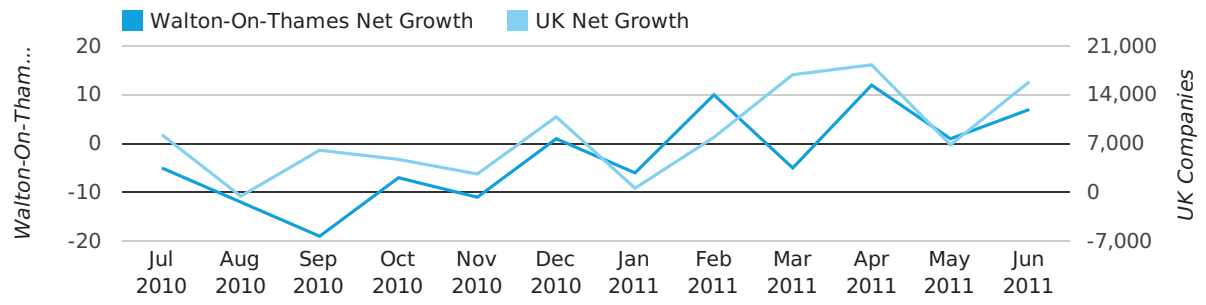

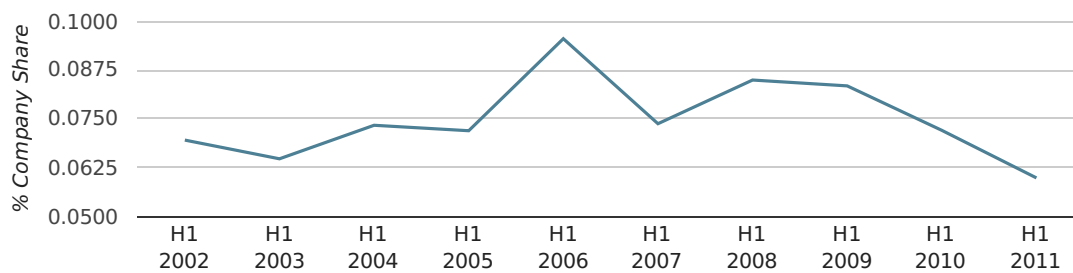

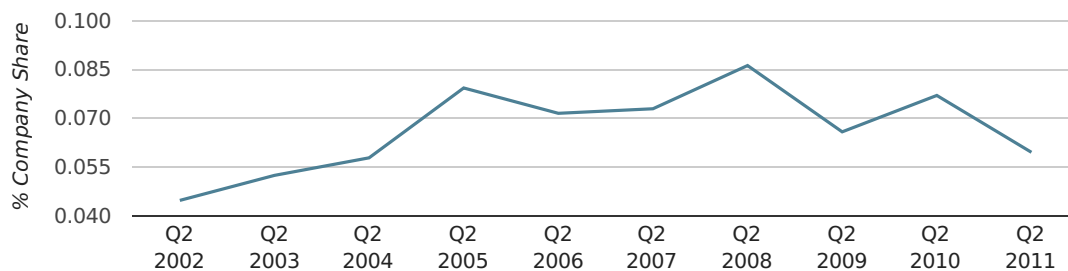

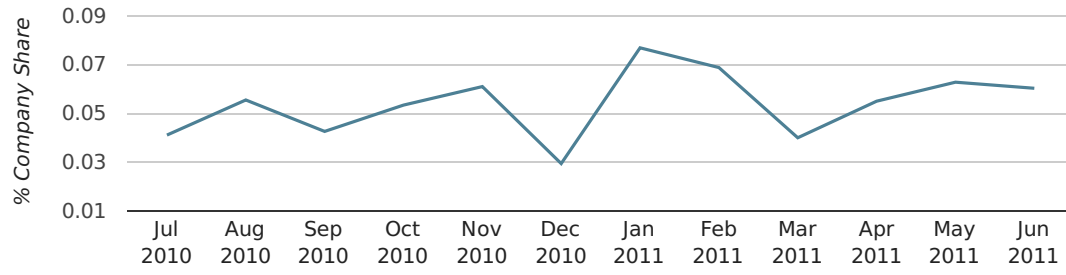

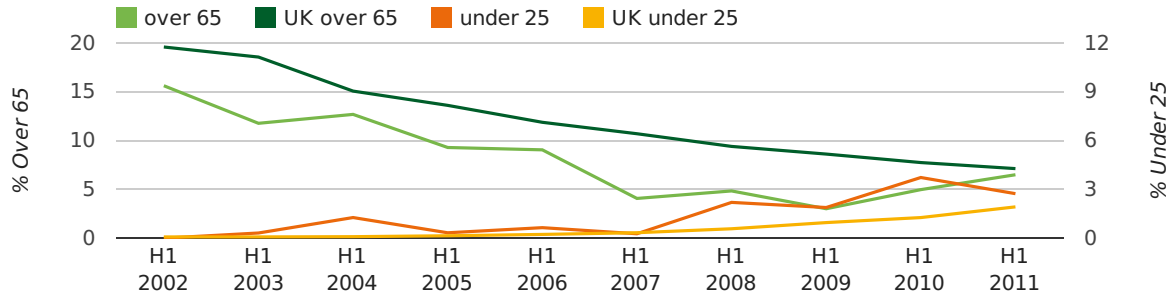

director age by half year



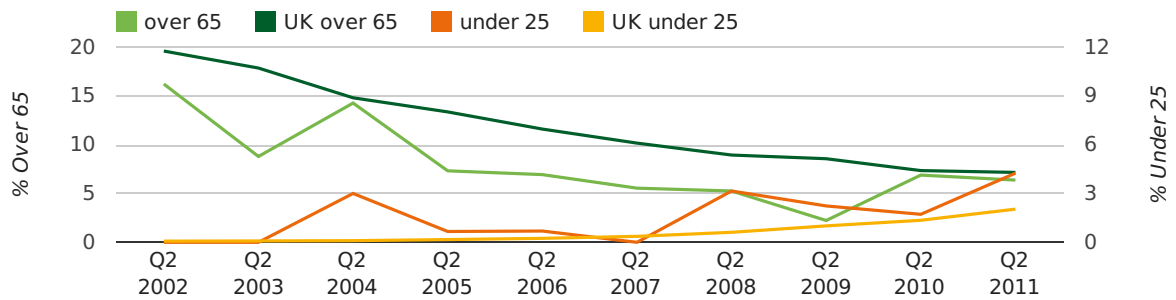

director age by quarter

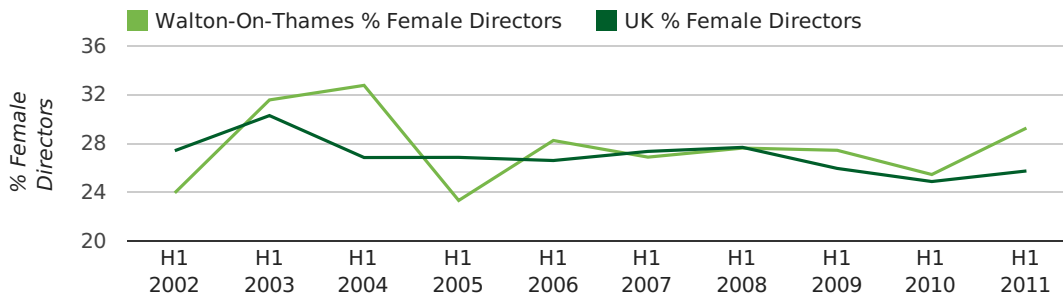


Half Year Data (Jan-Jun 2011)

The record first half year for female directors in Walton-On-Thames was 1861 when 40.0% of all directors were female.

29.3% of all director appointments in Walton-On-Thames in the first half of 2011 were female. This compares to a UK average of 25.7% for the same period.

director gender by half year

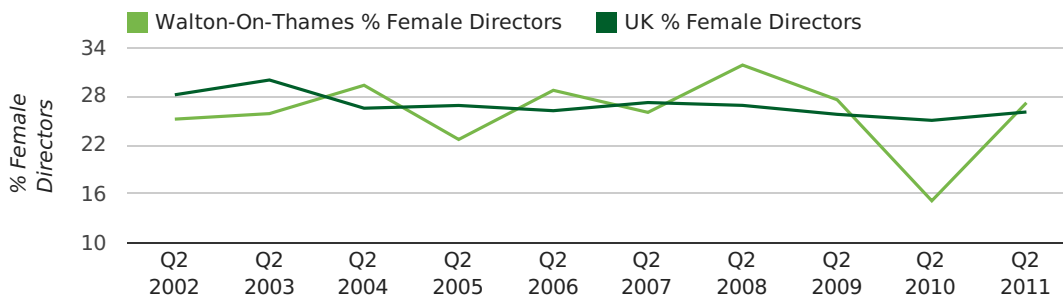


Quarterly Data (Q2 Apr-Jun 2011)

The record second quarter for female directors in Walton-On-Thames was in 1866 when 66.7% of all directors were female.

27.2% of all director appointments in Walton-On-Thames in the second quarter of 2011 were female. This compares to a UK average of 26.1% for the same period.
