




# Quarterly Data (Q2 Apr-Jun 2011)



#### dissolved companies by half year




# Quarterly Data (Q2 Apr-Jun 2011)

A total of 38 companies were dissolved in Ware during the second quarter of 2011 (Apr 2011 - Jun 2011).













#### director age by half year





The percentage of directors over the age of 65 was 3.7% compared to the UK figure of 4.3%.


#### director age by quarter
