




A total of 52 companies were registered in Ware during the second quarter of 2012 (Apr 2012 - Jun 2012).






# Quarterly Data (Q2 Apr-Jun 2012)

A total of 48 companies were dissolved in Ware during the second quarter of 2012 (Apr 2012 - Jun 2012).







#### net growth by quarter









#### director age by half year




## Quarterly Data (Q2 Apr-Jun 2012)

The percentage of directors under the age of 25 was 1.2% compared to the UK figure of 5.2%.


The percentage of directors over the age of 65 was 6.0% compared to the UK figure of 3.3%.

#### director gender by half year


