

A total of 1,898 companies were formed in Warrington in 2011. This total is 15.3% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

#### new companies by year




# Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 1,019 companies were formed in Warrington. This figure is 31.3% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Warrington occurred in 2003 when a total of 1,252 were formed.

#### new companies by half year




A total of 503 companies were registered in Warrington during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





## dissolved companies by year




# Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 838 companies were dissolved in Warrington. This figure is 8.8% higher than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Warrington occurred in 2008 when a total of 8,444 were closed.

#### dissolved companies by half year




A total of 444 companies were dissolved in Warrington during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### dissolved companies by quarter


A total of 435 companies were added to the company register for Warrington in 2011. This number represents growth of 26.4% which compares unfavourably to the UK figure of 34.6%.




## Half Year Data (Jul-Dec 2011)




Net company growth for Warrington during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 59 companies.











#### director age by year





#### director age by half year



#### director gender by year




# Half Year Data (Jul-Dec 2011)

## director gender by half year


