Q1 2011 saw a new record in company registrations in Warwick when compared to any previous Q1.


Q1 2011 was a record quarter for company registrations in Warwick when compared to any quarter in history.


### new companies by quarter


Q1 2011 saw a new record in company closures in Warwick when compared to any previous Q1.



### dissolved companies by month












