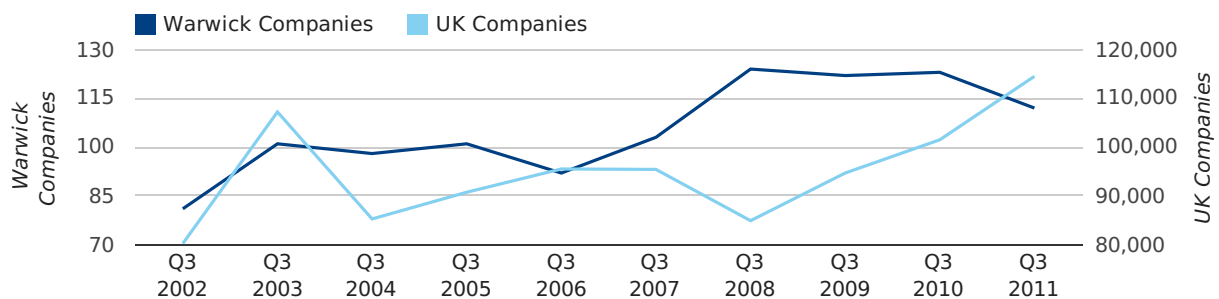
Quarterly Data (Q3 Jul-Sep 2011)

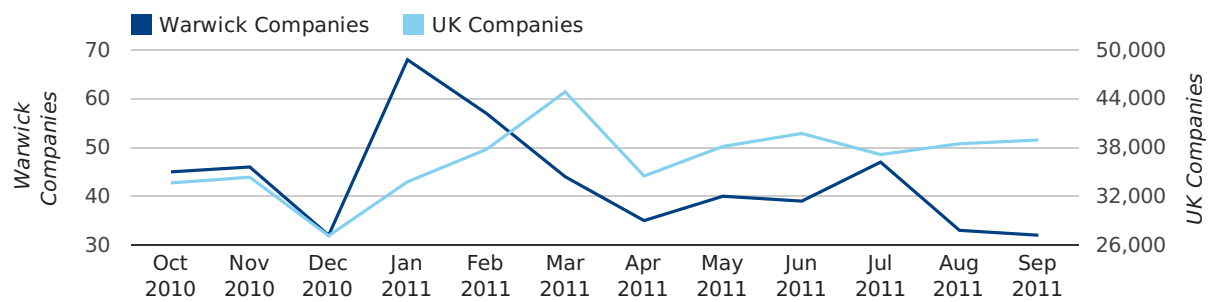

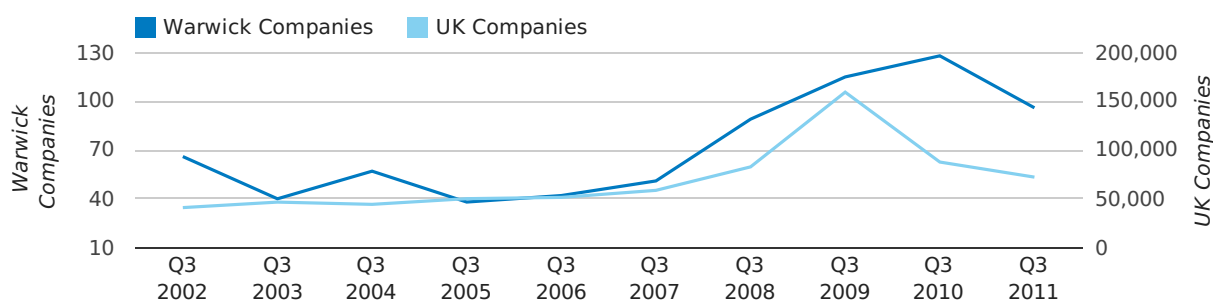
Quarterly Data (Q3 Jul-Sep 2011)

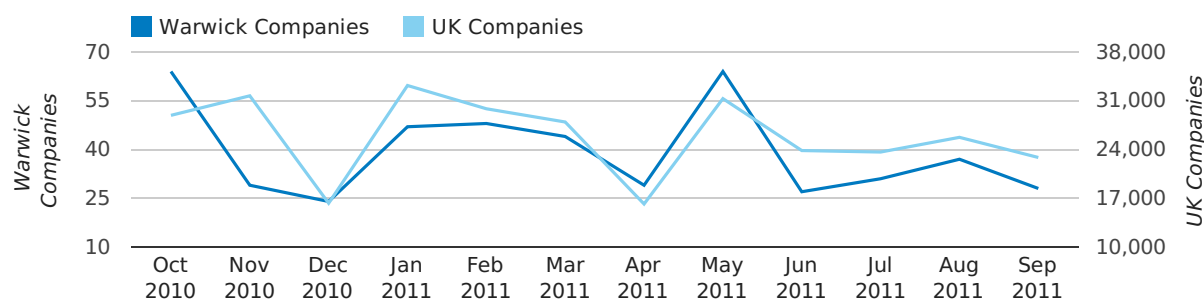

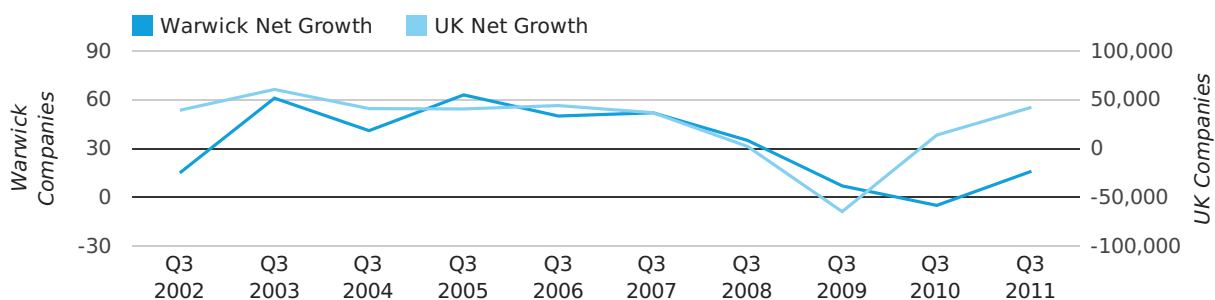

This represents an increase of 420.0% on the same period last year.

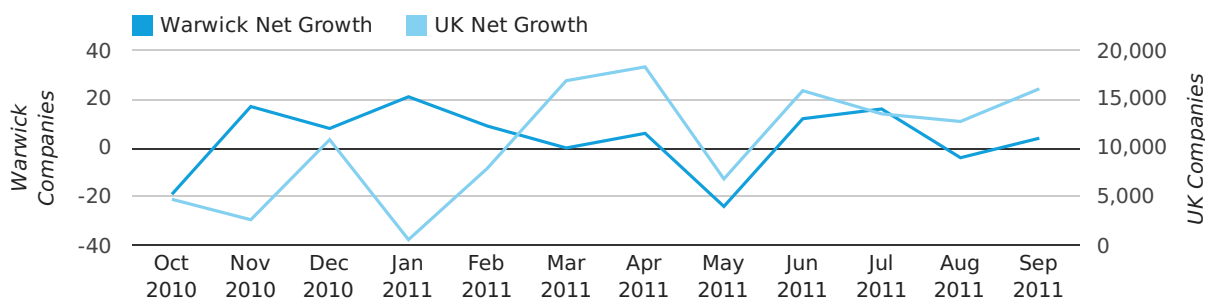

net growth by month



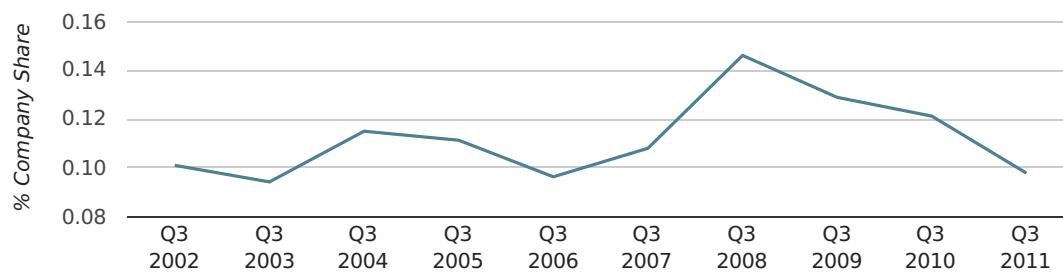

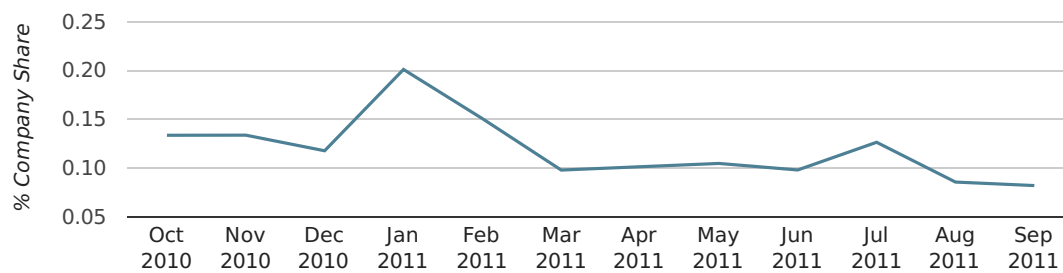

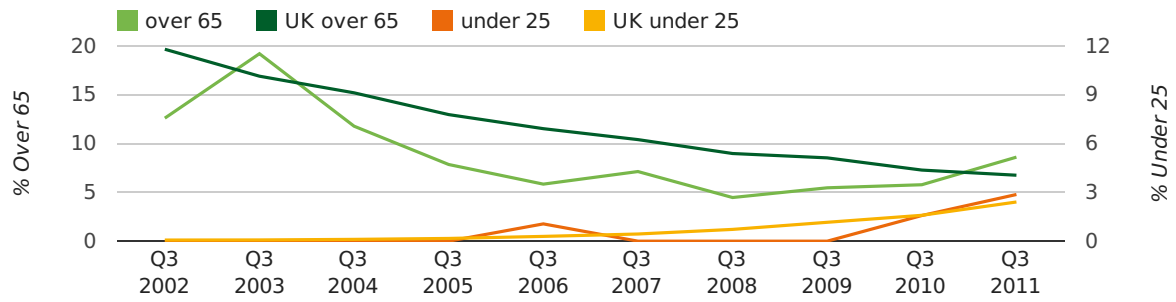
Quarterly Data (Q3 Jul-Sep 2011)

director age by quarter

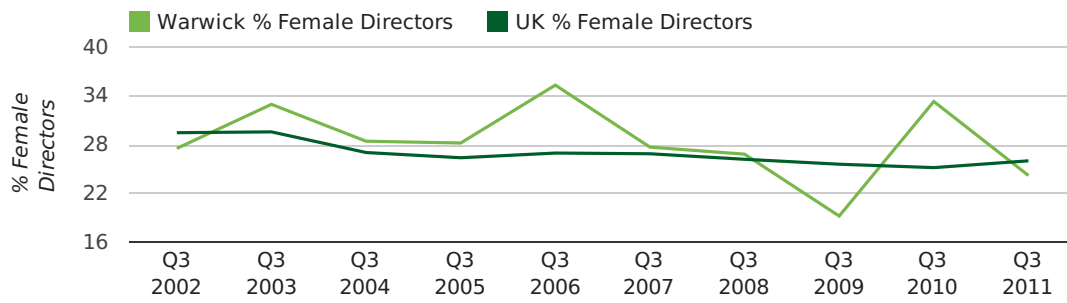


Quarterly Data (Q3 Jul-Sep 2011)
