

new companies by year




Half Year Data (Jul-Dec 2011)

new companies by half year




A total of 96 companies were registered in Warwick during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




Q4 2011 saw a new record in company closures in Warwick when compared to any previous Q4.




A total of 16 companies were added to the company register for Warwick in 2011. This number represents growth of 3.1% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Warwick during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was -24 companies.





company share by year




company share by half year





director age by year





director age by half year



director gender by year




Half Year Data (Jul-Dec 2011)
